New Chwang Under Martial Law.—Jury in Burton Case Sent Back to Room.

DENVER, Col. March 28—

Twelve deported miners who attempted to return to Teuridi under protection of an injunction have been again deported and warned never to return.

NEW CHWANG, March, 28—This city is now under martial law by order of Viceroy Alexander. The order is looked upon as a Russian challenge to neutral nations, especially China who may resist. The trade is completely tied up by the contraband law.

ST. LOUIS, March 28—The jury in the case of Senator Burton returned a verdict at 12:15 today but the judge discovered that the jury had failed to dispose of the third count in the indictment and sent the jury back to reconsider. The court believes the verdict will be guilty.
