SACRAMENTO, Cal., April 1—

Masked robbers held up the south bound express on the Southern Pacific at Copley this morning. Express messenger refused to open his car door and was instantly killed. The safe was then opened with dynamite, but it is not known what plunder was obtained. A posse is in pursuit.

TOKIO, April 1—The first party correspondents were permitted to go to the front today. Their release is taken as being important as conflict was being waged where no news was received.

SEOUL, April 1—The Japanese are quick in following up the advantages gained by the Russian defeat at Chwang Ju to march forward to the Yalu, following almost on the heels of the enemy. Much skirmishing is reported in the district between Ping Yang and Wiju in which many Japanese are being killed.

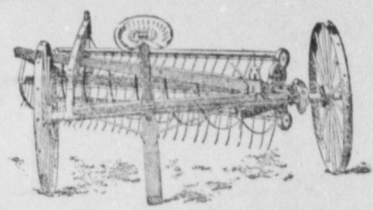

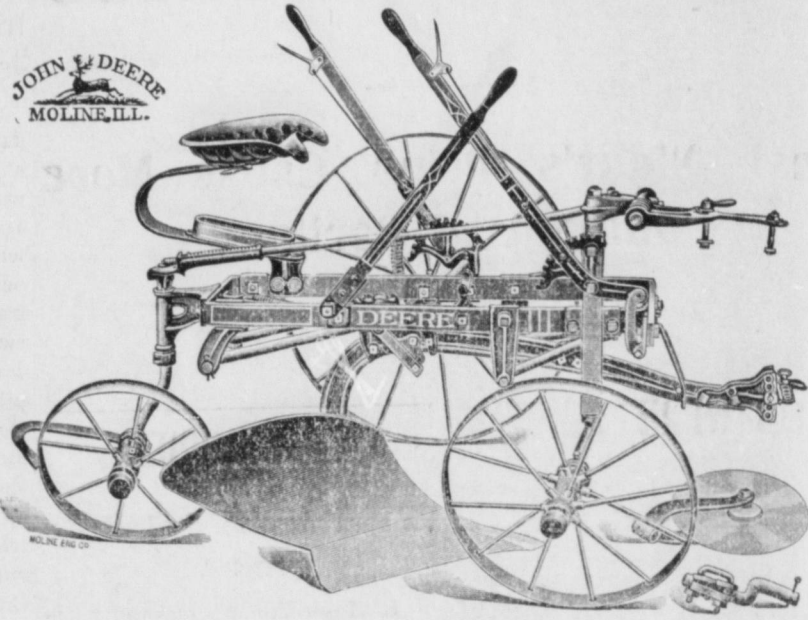

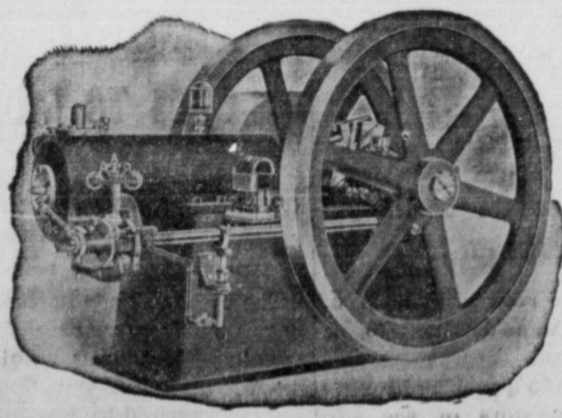
