### RAILWAY CASE

Erie Proves Their Name in Indiana is Chicago and Erie.

After almost a solid week to the hearing of evidence in the damage case of Samuel R. Marshall vs the Chicago & Western Indiana, the Erie and the Chicago, Indianapolis and Louisville railroads in circuit court, it was brought out this afternoon that the Erie railroad does not exist in Indiana. In other words its name is the the Chicago & Erie stopping at the Ohio line. Time tables, newspaper advertisements and other articles were produced as evidence to show the company goes by the name of the Erie. The prosecution then made a motion for leave to so amend its case as to change the name Erie to Chicago & Erie. On this motion there was an extended argument, the jury being withdrawn. The court sustained the motion and the case continued. It is thought all the evidence will be completed this evening and the arguments will be made in the vacation next week.—Huntington News Democrat

Indiana Educational Exhibit Ready for Worlds' Fair.

The committee of the world's fair commission which is arranging the Indiana educational exhibit has completed practically all of its work. The exhibit will be shipped to St. Louis about April 15. All the exhibits of the schools of the state have been prepared for shipment. Exhibits from Wabash and Earlham colleges and the State Normal school have not been sent, but they are expected within a few days.

The college exhibits is the only thing that has not been fully arranged by the committee. The booths are being now placed in the educational building at St. Louis and will be ready to receive the display when it is shipped to the exposition. A committee of artists will pass on the work that is to go into the woman's department Monday. The office on the commission is now filled with the shipments from various points of the state of china and needle work and other things particularly interesting to women. Some valuable specimens of china painting have been received.


