SYSTEM OF GRADATION

FOR

Jasper Co. District Schools.

Adopted October 13, 1873

FIRST READER GRADE.

1. Correct reading of the lessons in McGuffey's First Reader.

2. Spelling of all words in the same lessons, oral or written, by letter or sound.

3. Printing and writing the same on slate, or with lead pencils on paper.

4. Counting and combining the ones, twos and threes to one hundred.

5. Language lessons on familiar objects.

6. The names and uses of the punctuation marks and other characters used in the lessons.

7. The names of the cardinal points of the compass, and the direction of the principal objects in the vicinity.

SECOND READER GRADE.

1. Correct reading of the lessons in McGuffey's Second Reader.

2. Spelling of the words in the same, as in the First Reader Grade.

3. Writing the same lessons as a copying exercise, and regular writing exercise in Eclectic Primary Copy-Book.

4. Construction and mastery of the fundamental tables, and combination of numbers, composed of any or all of the nine digits.

5. State maps of familiar localities.

6. Language lessons, oral and written, continued.

THIRD READER GRADE.

1. McGuffey's Third Reader studied according to directions in previous grade.

2. Spelling of the words in the same with use of dictionary in defining, and classification of the elementary sounds.

3. Regular drill in writing from Eclectic Copy-Books.

4. Ray's Third Part Arithmetic, through Fundamental Rules and Cancellation.

5. Eclectic Primary Geography, with regular drill in Map-Drawing.

6. Language lessons, with classification of objects, study of their parts and properties.

FOURTH READER GRADE.

1. McGuffey's Fourth Reader, with regular elocutionary drill in emphasis, inflection, articulation, pitch and expression.

2. Spelling of the words in the same with regular spelling lessons from McGuffey's Spelling Book; and definitions from Webster's Dictionary.

3. Arithmetic through Decimal Fractions.

4. Pinneo's Analytical Grammar.

5. Eclectic Intermediate Geography.

6. Language lessons, embracing common compositions, letters, notes, business forms, &c.

FIFTH READER GRADE.

1. Select Reading with regular Elocutionary drill.

2. Ray's Third Part Arithmetic completed.

3. Analytical Grammar completed.

4. Intermediate Geography completed.

5. History and Physiology studied.

6. Regular drills in composition, declamation and the art of expressing ideas.
