

**Newspaper Decisions.**

II. Subscribers who do not give express notice to the contrary are considered wishing to continue their subscription.  
2. If subscribers order the discontinuance of their periodicals, from the time to which they have received them, they are responsible until they have settled their bills and ordered them discontinued.  
4. If subscribers move to other places without notice, they are responsible for the bills sent to the former direction, they are held responsible.  
5. The courts have decided that "refusing to take payment from a subscriber, and sending him to another, is prima facie evidence of intentional fraud."  
6. Any person who receives a newspaper and does not pay for it, has no claim to it or, not, is held in law to be a subscriber.  
7. If subscribers pay in advance they are bound to give notice to the publisher at the end of their time, if they do not wish to continue taking it; otherwise the publisher is authorized to send it on and the subscriber will be responsible until he expiates it with payment of all arrears.
