A hammock should be suspended

where the head will always be higher

than the feet, and much of the com-

fort of one who uses it depends upon

the proper observance of this fact.

The hook which supports the head

end should be about six feet from the

ground; that at the foot and three and

one-half feet. The rope at the head

end should be fastened to the hook

about a foot from the hammock, while

at the foot the rope should be about

four and one-half feet long. This

gives perfect freedom for swinging

the lower part of the body, while the

head moves but little. If these sim-

ple rules are observed much comfort

can be found in a hammock.

Mr. Talmage aptly quoted John Randolph, who once proclaimed in Congress; that he had found the philosopher's stone, "Pay as you go,"—and delivered on the whole a satisfactory and instructive discourse against the folly of living, not only beyond but even up to the uttermost point of one's income. The number of people who do this is constantly increasing. A voice of warning from other moral teachers might possibly give some of them pause.
