Reynolds, a male inhabitant of the State of Indiana, and a man of good moral character, and not in the habit of becoming intoxicated, and a fit person in every respect to be intrusted with the sale of intoxicating liquors, will make application for a license to sell and barter in less quantities than a quart at a time, Spirituous, Vinous, Malt and all other intoxicating liquors which may be used as a beverage, with the privilege of permitting the same to be drank in and upon the premises where sold and bartered, at the regular September session of the Board of Commissioners of Jasper county, Indiana, to be held in the Town of Rensselaer, commencing on the fifth day of September, A. D. 1887. The precise location and description of the premises where said liquors are to be sold and bartered is as follows, to-wit: In a one-story frame building situate on land described by metes and bounds as follows, to-wit: Commencing at the south-westerly corner of Block four (4) at the intersection of Washington and Front streets, in the original plat of the Town of Rensselaer, Jasper county, Indiana, and running thence in a southerly direction along the easterly line of Front street in said Town a distance of one hundred and seventy-two (172) feet and three (3) inches, and from thence westerly on a line parallel with Washington street in said Town fifty (50) feet to a point on the westerly line of Front street, in said Town, to the southeasterly corner of the premises where said liquors are to be sold.
