



## DEMOCRATIC CONVENTION.

The Democratic voters of Jasper county, and all other enemies of monopolies, trusts and combines, who believe that the adoption of Democratic principles are essential to the welfare of the whole people, are requested to meet in mass convention at the usual voting places, in the various townships, on

SATURDAY, JULY 26, 1890, at 2 o'clock p. m., to transact the following business:

1st. Appoint a committee of three, who, with the chairman of township committee shall prepare a complete and accurate poll of the voters of the township, the same to be delivered to the chairman of the central committee on the date of the county convention.

2d. Select such other committees as may in the judgment of the convention be necessary to a complete and thorough organization of the party in the township.

3d. Select one delegate for each ten votes, and one for each fraction over five votes cast for C. C. Matson for Governor at the November election of 1888. The above apportionment entitles the various townships to delegates as follows:

AS BAD AS BROTHER MARSHALL. "If the consumer pays the tax," why do British manufacturers clamor for relief "from the American tariff."—Monticello Herald.

The American tariff is to a great extent prohibitory in its operations. The American "consumer" who might prefer British manufactures of certain grades at a fair price is not willing to pay the price he could get them for abroad and in addition the duty levied at our custom houses when landed here. The British manufacturers complain of a tariff which, while it prevents the American "consumer" from purchasing abroad at the same time compels him to buy at exorbitant rates, made possible by the tariff, of home manufacturers. If the "consumer" buys an article of foreign manufacture the tax he pays goes into the U. S. Treasury; if he buys a home-made article, price he pays, far exceeding cost of production and fair profits goes into the pockets of the home manufacturers. Owners of the products of labor alone reap the benefits of the tariff; labor itself

gets none of it. For one to doubt, at this day, that the 'consumer' pays the tax, is symptomatic of 'softening of the brain.' Soak your head, Bruce.

It is the duty of the county commissioners at every regular session to visit the poor asylum and examine into its management, etc. The commissioners of Jasper county at the June term improved upon that plan by appointing a committee to perform that duty.—We are not informed as to the compensation to be allowed at the expense of the taxpayers.

Miss Allie Kinney, of Rensselaer, is visiting Miss Toodie Ellis, south-east of town.—Monticello Herald.

The unveiling of Hendricks monument at Indianapolis takes place July 1st. The Monon Route will sell round trip tickets to any wishing to attend, from any point on the line, at the rate of one cent per mile. Tickets are good only on July 1st going and coming. But purchasers at Rensselaer may take the train which passes Rensselaer at 11:27 on the night before and returning may take the train from Indianapolis and arrive here at 4:05 on day following the unveiling. This will give the entire day of July 1st in Indianapolis. The round trip rate from Rensselaer is \$2.25, and from other Jasper county points at proportionate rates.

By the arrangement with the Monon their No. 10 north bound train will hold at Reynolds for the early morning train east on the Panhandle. This will give the people of Remington, Wolcott, Seafield and vicinity, the opportunity to go to Chicago stay 4½ hours and return home the same day. It also will permit the people of Remington to visit Rensselaer, giving them nearly the whole day there, and return in the evening.—Remington News.
