DEMOCRATIC CONVENTION.

The Democratic voters of Jasper county, and all other enemies of monopolies, trusts and combines, who believe that the adoption of Democratic principles are essential to the welfare of the whole people, are requested to meet in mass convention at the usual voting places, in the various townships, on

SATURDAY, JULY 26, 1890, at 2 o'clock p. m., to transact the following business:

1st. Appoint a committee of three, who, with the chairman of township committee shall prepare a complete and accurate poll of the voters of the township, the same to be delivered to the chairman of the central committee on the date of the county convention.

2d. Select such other committees as may in the judgment of the convention be necessary to a complete and thorough organization of the party in the township.

3d. Select one delegate for each ten votes, and one for each fraction over five votes cast for C. C. Matson for Governor at the November election of 1888. The above apportionment entitles the various townships to delegates as follows:

Table listing delegates by township: Hanging Grove (4), Walker (7), Marion (20), Newton (7), Kankakee (4), Carpenter (17), Union (8), Gillam (4), Barkley (8), Jordan (7), Keener (3), Wheatfield (6), Milroy (3).

The delegates so selected will meet in delegate convention in the Town of Rensselaer, on

SATURDAY, AUGUST 2, 1890, at 1 o'clock p. m. to nominate a county ticket to be voted for at the November election, 1890, and also to appoint delegates to the various conventions.

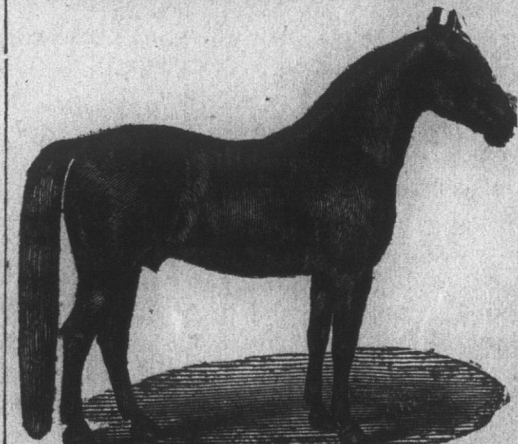

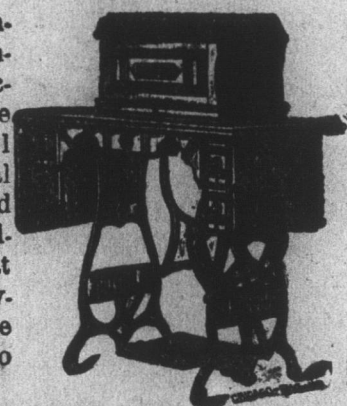

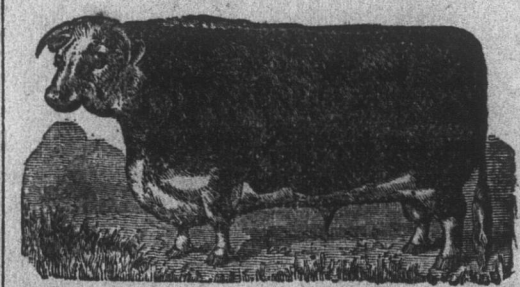
