Indianapolis, Oct. 27.—(Special.)—Indiana people by personally meeting Senator Harding, his gracious wife, his patriotic father, his physician brother and his attractive sister have found them to be "regular folk," to use a complimentary term that many have applied.

A few weeks ago civil war veterans attending the G. A. R. national encampment here had an opportunity to greet Dr. George T. Harding, Sr., father of Senator Harding, as their comrade. Dr. George T. Harding, Jr., a physician of Columbus, O., and a brother of the candidate, was here with his father during the encampment. Then came opportunity for personal acquaintance with Senator and Mrs. Harding on their recent Indianapolis visit, and on Friday Indiana school teachers had the pleasure of meeting Miss Daisy Harding, a high school teacher at Marion, O., who is a sister of the nominee. The mother of Senator Harding, who was Phoebe Elizabeth Dickerson, is dead, having passed away in 1910.

Senator Harding, comes of the sturdiest Anglo-Saxon-Celtic ancestry and the clear vision, hardiness, determination and other racial qualities that characterized his ancestors have been the principal and the most valued heritage handed down to the presidential nominee of the Republican party.

Senator Harding's father, Dr. George Tyrone Harding, comes of old New England stock. No less than six Hardings landed on American shores before the revolution. Abraham came to Massachusetts and his widow settled in Boston; George Harding went to Salem, John to Weymouth and Robert to Connecticut.

From the Connecticut family of Robert Harding came Capt. Stephen Harding, whose son, Abraham, was the father of Amos Harding. Amos Harding reared a family of fourteen boys, all of whom bore biblical names with the exception of George Tyrone Harding, who was the father of Charles Alexander Harding and William Perry Harding. Charles Alexander Harding left but one son, Dr. George Tyrone Harding, the father of Senator Warren G. Harding.

Senator Harding was named for the Rev. Warren Gamaliel Bancroft, a Methodist preacher, and an uncle by marriage.

Senator Harding's mother spent practically all of her life in Ohio and was known in her community as a very devout woman, especially versed in Biblical literature. Senator Harding's grandparents were Charles and Mary Ann Crawford Harding. Warren Harding is said by those who know him intimately to have inherited his fine and gracious traits and unusual gifts of mind and pen. Warren Harding and his mother were genuinely devoted to each other, their neighbors at Marion, O., say, and their lives were exemplary of the highest type of affection in the home.

AGRICULTURAL NEWS.

Ear-to-Row Demonstration.

The "Ear-to-Row" Demonstration conducted by R. S. Thomas of the Soil and Crop Department at Purdue, was a decided success. A fair-sized group of farmers, headed by the County Agent, was present. This experiment proved, without a doubt, that each individual seed ear has a distinct value as seed, apart from another ear. It proved that in the selection of seed corn, the grower should exercise great care in selecting seed that does not carry an over amount of starch, as the vitality and vigor of seed corn is largely determined by its freedom from disease and starchiness. Great care should be exercised that no seed be selected that shows signs of disease, either in ear or stalk, as these defects are absolutely sure to show up in the crop. In this experiment several diseased ears were used as seed. Fully 75 per cent of this planting was found to be affected by stalk root disease, causing stalk to fall, and ears were small and infested by disease similar to the parent ear.

The results of the seeding of two ears in this demonstration, selected from one township, was exhibited in a down town window and attracted universal attention. The one ear produced fifty bushels to the acre. It had very starchy kernels and the resulting ears were small and consisted of many nubbins. The other ear yielded 80 bushels to the acre and was free from starchiness and well adapted to the soil and climate, which is shown in the resulting corn that has a uniformity of type.
