Regimental Orders.

VINCENNES, July 14, 1819.

The Regimental DRILL MASTER of the First Regiment of Indiana Militia will be held on the Commons, near the borough of Vincennes, on the 13th and 24th days of August ensuing. The Officers, non-commissioned officers and musicians of the regiment will meet on the regimental parade ground on the 13th of August at 11 o'clock, A. M. precisely, armed and equipped according to law, and prepared to encamp one night out, and remain on the muster ground during the two days. The Commissioned Officers will do well to examine the date of their commissions, and see whether the time for uniforming is nearly elapsed. They will likewise be particular in bringing forward their commissions, as it has become necessary to examine them relative to the oaths required by law to be taken, and the certificate necessary to be endorsed on the back thereof.

* * All the Regimental Staff, Commissioned and Non-commissioned Officers will attend:—It is hoped they will appear in complete uniform.
