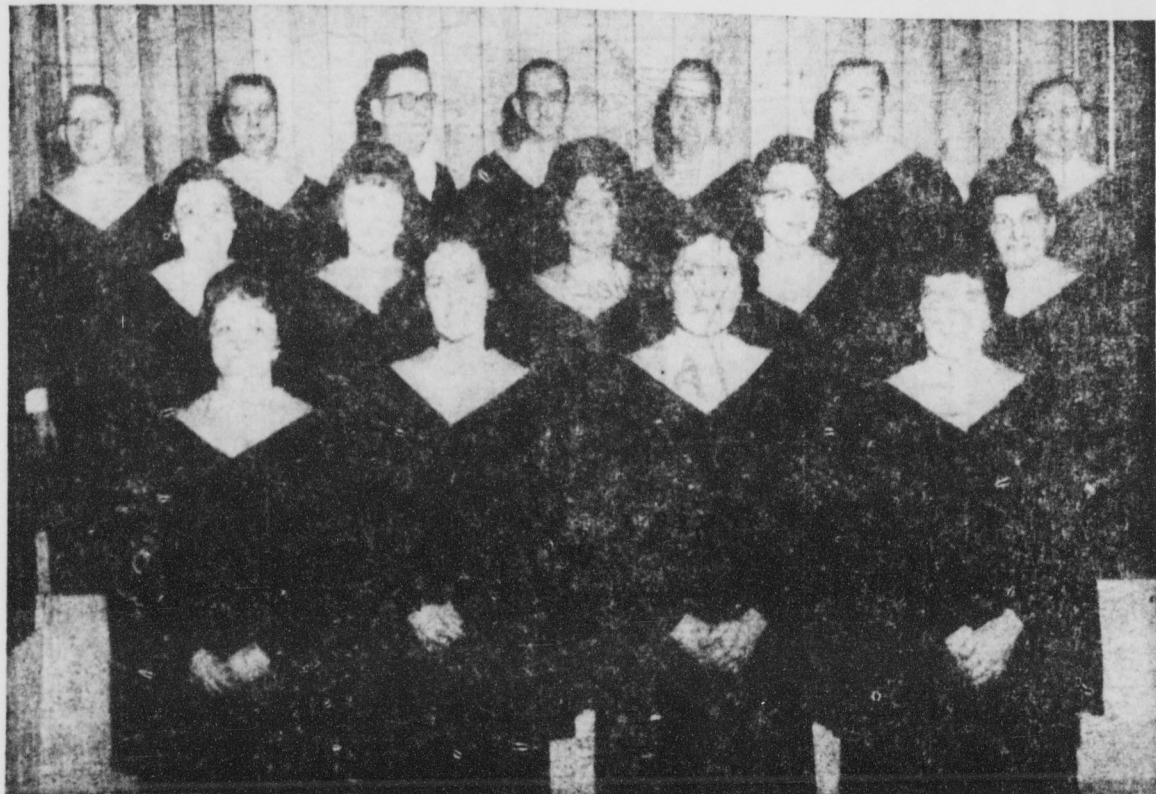


Koontz Lake Church Choir To Present Easter Cantata

PLJ Beard Looks Into Work-Study Program

The Superintendent reported to the board concerning a "work study" program that offers local employment for vocational education students.

The work-study program is designed to offer part-time employment for youths that would have need for earnings to assist their being a full-time high school student.

The program employs only the young people who are (a) enrolled as full-time students in a vocational program, (b) would have need for employment to assist their educational needs, and (c) are at least 15 and less than 21 years of age.

For the Tyner and Walkerton schools, there are fourteen students employed. They will work in areas of building maintenance, grounds maintenance, office helpers, cadet teacher, and cafeteria workers.

Students will work nine hours per week and will be reimbursed \$45.00 per month. The program is under Adult Supervision; Federal monies will be used to operate the program.

"In The Pastor's Study" A LOVING GOD & AN ETERNAL HELL

"AND THESE SHALL GO AWAY INTO ETERNAL PUNISHMENT: BUT THE RIGHTEOUS INTO LIFE ETERNAL." MT. 25:46

QUESTION: God is love; how can He punish eternally as a loving Father?

ANSWER: Any loving father who had a son who was unfit to be among society would take him out of society permanently — he would do this out of love. God is holy, basically, and NOT punishing sin would be out of harmony, not the punishing of it.

QUESTION: Could a good God permit people to suffer in the next world permanently?

ANSWER: He permits it here. Therefore, who says it is inconsistent to continue in the future? At that time only suffering will come on evil men (although today they may be regarded as fine citizens).

QUESTION: I could not be happy in Heaven knowing that people are in Hell.

ANSWER: This is said with little thought. There are people in prisons today awaiting executions and at the same time we are just as happy — we laugh at the comedies, tell jokes, etc.

QUESTION: Preaching eternal punishment frightens men and no man can be frightened into becoming good.

ANSWER: True. But he can be frightened into coming to Christ and getting saved and then Christ can make him good. (Note that right is right and wrong is wrong. People ought to do right simply because it is right. Wrong ought to be punished simply because it is wrong. Usually when we stop preaching eternal judgment, we stop preaching discipline, imprisonment and the electric chair, etc.)

QUESTION: It is not fair for God to punish forever for sins committed in a brief lifetime.

ANSWER: How do you know? Who is to say what duration of time should be given as sentence for the man who raises his fist in defiance against God, saying, "I will not come to Christ. I do not have to get saved. Christ can go His way and I will go mine!"
