MARY WILL HAVE TO READ PAPERS

Nevada's Notice of Suit Over Divorce Published Today.

MINDEN, Nev., April 17.—Official notice that the state of Nevada is proceeding against Mary Pickford to set aside her recent divorce from Owen Moore, was to reach the film star today.

Service in the suit was by publication. Attorney General Leonard B. Fowler was prepared to combat the first move of the defense, expected to be an application for a demurrer. Fowler's staff said it had information the case would be hard fought, and if necessary, carried to the supreme court.

The petition filed by Fowler asks that the divorce of Gladys E. Moore (Mary Pickford), be annulled, and that she return to her original status as the wife of Owen Moore.

Fowler alleged there was an agreement between the actress and Douglas Fairbanks to wed as soon as a divorce was obtained from Owen Moore. He charged collusion in the appearance of Moore in Nevada at a time when he could be served with notice of the divorce petition.

Fowler claimed the Nevada courts had no jurisdiction in the case since Moore and Miss Pickford were married in New Jersey and later had lived in Los Angeles.

The suit was brought to uphold the integrity of the state courts and the sovereignty of the state, he said.



LEGION OPPOSED TO BONUS ONLY

D'Olier Notifies Congress Fourfold Plan Is Favored.

A bonus with nothing else will not satisfy American legion officials. Franklin D'Olier, national commander of the American legion, has notified members of congress who have legion affairs in hand to this effect, it was announced from national headquarters today.

A report current throughout the country that the house ways and means committee contemplates eliminating from the bill proposed by the American legion, for the adjusted compensation of former service men, the provisions for home aid, land settlement and vocational training, leaving only the cash bonus, has resulted in the receipt of complaints at legion headquarters from every part of the country," said the legion announcement.

The clauses which the ex-service men desire left in the bill provide for land settlement, whereby former service men and women receive \$1.50 for each day of service, to apply on the purchase of land and government projects, or loans for buying equipment; home aid, with \$2 for each day of service to apply on the purchase of a home or farm; or vocational training, with \$1.50 for each day of service to be paid as long as the recipients are obtaining education from the government.

The proposed bill provides for a choice of any one of the above three benefits, or a cash compensation of \$1.50 for each day of service, to be paid within a year after the approval of the bill.
