

MEN OUTSIDE OF BASEBALL PROBABLY WILL MAKE UP COMMISSION

TRIBUNAL MAY BE APPOINTED FOR BASEBALL

Magnates Finally See Light and Propose a Real Governing Body.

SCANDAL PROBE STILL ON

CHICAGO, Oct. 2.—Establishment of a high tribunal of baseball that would take control of the game from the hands of magnates and players is proposed in hand. Those who would be considered as direct representatives of the public is being urged today as the most feasible plan of keeping spotless the nation's game, which now in the process of being cleaned up. Four of the leading ball clubs of the major leagues have approved the plan while A. D. Lasker, a founder of the Chicago club, is credited with having originated it.

Already the names of some of the nation's famous men have been brought to the attention of possible members of this "super-court" of baseball. Among them are William Howard Taft, former President; Gen. John J. Pershing, General Leon Wood, William McAdoo, Sen. Hiram Johnson and Judge K. M. Handa.

WOULD HAVE FULL POWER.

The proposed plan would establish a tribunal of three members, whose authority over all baseball matters would be absolute. These three would be paid salaries higher than any received by men now in organized baseball. They would be given "absolute authority" over presidents of all leagues, club owners, players and every other person, act or thing connected with the national game.

The four major league clubs that have approved the plan are the New York Giants, the Pittsburgh Pirates, the Chicago Cubs and the Chicago White Sox.

Lasker, who is actively engaged in efforts to obtain approval of the plan from other baseball magnates, will ask the minor leagues to come in also when the national commission holds its annual meeting at Kansas City.

While the baseball world is revolving this latest scheme in its mind a temporary lull has arrived on the grand jury probe. The grand jury, which has been excused from the fans and the papers excited during the last week, the jury here proposes to call no witness today, but will resume its active inquest on Friday.

Attorney Macay Hoyne, who plunged actively into an inquiry upon his return from New York yesterday, has made the startling disclosure that most of the games in the major leagues were "fixed" during the 1920 season. Evidence which he uncovered in New York, Hoyne said, caused him to make the charge.

IASIS DENIES

OF "FIXED" GAMES.

"I have evidence that several of the 1920 games were 'fixed' and I have information that the grand jury

was to be told of this," Hoyne said. "While in New York I gathered together loose threads of a 1920 scandal which would far surpass that of last year, but I can say that this was the result of my investigation, but I will, I trust, the assertion that there is a bigger scandal coming in the baseball world."
