

ORDER NEW TRIAL
OF BRIDGE LEASEAppellate Court Sends Suit
Back to Hamilton County.

A new trial has been granted by the Appellate Court in the case of Edwin J. Roberts against Leo K. Fesler, auditor; Ed G. Sourbier, former treasurer; Louis W. George, G. H. Shirk and Joseph G. Hay, commissioners of Marion County, and the American Construction Company, in which an injunction is asked to prevent the defendants from making payment for the construction of a bridge over Fall creek on Senate avenue.

The Appellate Court sent the case back to the Hamilton County Circuit Court, from where it was appealed, for retrial, after the lower court had shown prima facie error in the failure of the appellees to file a brief in the case.

It was alleged by the plaintiff that the defendants in 1917, after advertising for bids for the construction of the bridge, failed to make any entry on the records of the awarding of the contract, after the sum of \$125,000 had been appropriated for payment.

The defendant set forth that he had examined the records of acts of the commissioners, and that he failed to find any entry of awarding of the contract.

Judgment was rendered by the lower court in favor of the defendants.

The Appellate Court reversed the action of the lower court.

ARMENIAN RELIEF
WORKERS MEETNew Plea for American Help
Made at Claypool.

Pleas to succor Armenian orphans were made by the speakers at the Indiana Near East Relief State Conference, held in the Palm room of the Claypool Hotel.

American money is now taking care of 16,000 orphans, while there are 200,000 more wandering over the deserts, it was said at the conference.

Charles V. Vickrey, general secretary of the national organization, declared there is no home for the Armenian orphans if she is not aided by American philanthropy, and that it will be necessary to feed and clothe them another year.

Dr. Isaac M. Yonan, a native of Assyria, who was driven across the desert with a party of 60,000 refugees by the Turks, gave an account of the horrible experience of that journey, emphatically appealing for Armenian relief.

Mrs. Ruth Hoffman, American Red Cross nurse who served with the organization in Armenia, gave an account of her experiences in relief work in the refugee camp, telling of the great accomplishments among the children.

"Could all American mothers get one glimpse of some of my 'returns' they would keep their hearts open to all future appeals from the Near East Relief, she said.

A program for the State work was laid out by Clarence D. Rose, State director, and Alonso E. Wilson formulated a permanent constituency consisting of churches, Sunday schools, women's organizations, business and fraternal organizations and labor organizations.

At the luncheon at the Riley room, John H. Holliday presided and chairman, the speakers being Dr. Yonan, Mr. Vickrey, Miss Elizabeth B. Kelly, national speaker, and Senator James E. Watson.

FARMER WOUNDS
WOULD-BE BANDIT

John W. Deery, 518 West Main street, is in a serious condition at St. Vincent's Hospital, colay suffering bullet wounds, one of which penetrated the left lung and another the stomach, received in an attempt to hold up a farmer, Elmer Russell, living near the Highland golf links last night.

Russell told the police that some one giving his name as "Tom" called him to his bed at about 10 o'clock.

He dressed and went to the door with a shotgun.

In one of his pockets he had about \$200 and in the other he had a revolver.

The man asked him if he would sell him some horses he had in his yard and when told they were not for sale he asked the road to Noblesville.

Not waiting for an answer, Deery grasped Russell about the waist.

In the struggle Russell drew the gun and fired, the bullet striking Deery in the left lung.

Deery ran, followed by two men, who appeared when the shot was fired, and as they ran Russell fired three more shots, one striking Deery in the back and one in the thumb.

Deery was later found in the rear of the home of W. W. Evans, on Forty-fourth street, almost two miles from the hotel.

SCORE PREMIER'S
CARNARVON TALKBritish Press Sees Naught to
Help Irish Problem.

LONDON, Oct. 11.—Many prominent British newspapermen profess to see no gloom toward a settlement of the Irish question in the sensational speech delivered by Premier Lloyd George at Carnarvon, Wales, on Saturday.

"The premier lost his opportunity," said the Times.

"The speech does nothing to help Irish peace," declared Lord Northcliffe's Daily Mail.

"The speech suggests nothing to re-ads the government's failure to govern Ireland," was the comment of the Daily Graphic.

"It was not so much the despairing importance as blind folly," said the Daily News.

"Lloyd George will have the backing of all sane citizens and the speech will create a good impression," declared Daily Express.

"Ireland has already voted for an independent status," declared Arthur Griffith, acting president of the Irish Republic, according to a Central News dispatch from Dublin, quoting the Sinn Fein leader.

"The reply of the British government was raids, arrests and imprisonment and armed assassins, shooting and murders by the English," said the Standard.

Griffith was quoted further as saying that England could have a real peace with Ireland if she wanted it.

Premier Lloyd George made it plain that he intends to stand upon his Carnarvon speech and will not temper any of his harsh utterances.

When his attention was called to the attack of former Premier Asquith by a writer in the Standard, Mr. Lloyd George said:

"I notice that no mention is made by Mr. Asquith of the 'hellish policy of murder.' I do not propose to take any notice of Mr. Asquith's statement."

The former premier, in his attack upon the Lloyd George speech at Carnarvon, expressed the opinion that it showed the British Government was unable to solve the Irish problem.

MacSwiney's 60 DAYS Without

LONDON, Oct. 11.—Terence MacSwiney began his sixtieth day of fasting in Brixton prison today, with his mind as alert as ever.

His determination to continue his hunger strike until death or unconditional release was still firm, relatives said.

MORE DIE IN NEW

DUBLIN, Oct. 11.—With Sinn Fein attacks on the military renewed Ireland today awaited further police reprisals.

One officer was killed and four wounded Sunday when Sinn Feiners ambushed two motor lorries near Newcestre.

Eight soldiers were reported missing after the blowing up of a motor lorry near Castle Roche, County Roscommon.

Attacks on soldiers and police were reported at Belfast.

At Cork a large body of soldiers raided houses searching for arms and ammunition.

There was no opposition.
