Contractors to Receive Bonus for Finding Flowing Well.

'MORE FOR BEER OR WINE'

Park Board Increases Appropriations for Open Air Shows.

Pleasant Run will not dry up into a series of stinking frog ponds in the summer if a plan to discover flowing wells along the stream is successful.

The board of park commissioners today authorized negotiation of a contract with Charles Kraus & Sons, 402 W. Pratt St., whereby the firm will get \$2,500 if it establishes at least one flowing well or not less than 100 gallons a minute capacity along the stream in the east part of the city and \$600 if it fails.

"If you strike beer or wine we'll give you more than that," Mayor Shank told the firm's representative.
