

PUBLICLY PICKED TEETH, SHE SAYS

Wife of Hawkins Recites Basis
of Her Claim to Alimony
Allowance.

ATLANTA, Ga., July 28.—The hearing on the temporary alimony suit brought by Mrs. Fannie Manly Hawkins, former wife of Georgia society and a daughter of W. D. Manly, millionaire banker and manufacturer, against Morton S. Hawkins, Portland, Ind., businessman, begun unexpectedly in Superior Court here.

Mrs. Hawkins, who claims her husband is a "millionaire," and who is asking no specific amount of alimony, but "an amount relative to his income," declared that one of the reasons she left her home was because "he picked his teeth in public."

Hawkins charged that his 17-year-old wife was on several "wild parties with other men" while they were on their honeymoon in the Bahama Islands.


