

MER ROUGE MAYOR ADMITS PRESENCE IN HOODED MOB

KU-KLUX CHIEF OFFERS TO TELL KLAN ACTIVITIES

Witness Names Self and Dr. McKoin With Skipwith as Terrorist Members.

BLOODSHED IS PREDICTED

Cyclops Tells Attorney General He Is Pursuing Wrong Course in Case.

COURTHOUSE, Bastrop, La., Jan. 12.—Robert Dade, mayor of Mer Rouge, admitted today that he had participated in the reign of terror which State officials are probing in connection with the brutal murders of W. C. Daniel and Thomas Richards. Dade, re-called to the stand today, said he was in the hooded mob that accosted Daniel, W. C. Andrews and Henry J. Neelis a few days before the murders.

He named Dr. B. M. McKoin and Capt. J. K. Skipwith as being in the band of blackhounds. Previously Dade admitted he was a former klanman.

Offer Conference
Before the session began today State attorneys received an offer from Skipwith, exalted cyclops of the klan, to detail every activity of the organization since its founding here two years ago.

"You gentlemen are pursuing the wrong course in handling this investigation," Captain Skipwith told Assistant Attorney General Guion and Special Prosecutor Warren, when he met them as they were walking toward the courthouse. "If you desire, you can learn everything the Klan has done in this parish, you can learn it from the officials of the Klan."

The suggestion for a conference followed and Attorney General Clegg approved. No date has been set for the meeting. Skipwith said the State is making a mistake in its method of handling the open hearing, in that it is not confining itself to the murders of Daniel and Richards, but is digging into an old feud in the parish. This feud, Skipwith said, had died out.

"Bloodshed will be the result of this," he said. "The feud will be renewed. Why not leave the old thing alone and investigate this murder?"

MEASURE GRANTS WOMEN 'EQUAL' LEGAL RIGHTS

Removal of Property Limitations Is Provided.

Removal of legal limitations of married women is proposed in a bill introduced in the Senate today by Senator Miller of Marion County.

Married women would be allowed to acquire and hold property by gift or descent in their own names, according to provisions of the bill. They are accorded the same protection and exemption from seizure of property from sale as given any householder by the constitution.

Upon marriage, a husband is not liable for debts of his wife exceeding value of her personal property when she was married.

WASHINGTON, Jan. 12.—President Harding today nominated D. R. Crissinger, comptroller of the currency, to be Governor of the Federal Reserve board, to succeed W. P. G. Harding.

At the same time the President nominated James G. McNary, New Mexico, to the post of comptroller of the currency, to succeed Crissinger.

Crissinger is a banker from Marion, Ohio, Mr. Harding's home town. McNary has extensive business and banking interests in the Southwest. Both are Republicans.

Milo D. Campbell, Coldwater, Mich., was nominated to the Federal Reserve Board. He is a Republican.

BILL PLANNED TO PROTECT YOUTHS

Protection of Indiana's coming generations against the desire to use tobacco, caused by the prevalence of advertising of the various tobacco products, is the ambition of Representative Lonzo L. Shull of Sharpshooters, who Thursday introduced a bill in the House of Representatives which would make illegal all classes of such advertising.

Shull declared today he had no objection to the use of tobacco by men, but that he believed the youths of the State were taking too readily to the persuasiveness of certain cigarette advertisements, which he termed "lurid."

Moreover, he said, the sensibility of good advertising is being cheapened by the "luridness" of cigarette posters.

MOTHERS-IN-LAW HOME WRECKERS

Chicago Judge Says He Will Jail Them as Interferers.
