

GHERTY CASE UP TO JUDGE

It Will Rule on Mistrial Motions.

NEW YORK, Sept. 29.—Upon completion of secret arguments in chambers, Federal Judge Julian W. Mack will rule today whether the Government has overcome the law's presumption of innocence in the fraud trial of Harry M. Daugherty and Thomas W. Miller, officials of high rank during the Administration of President Harding.

Mack's ruling on mistrial motions which will be made by attorneys for the accused men will determine whether they must defend themselves from the charges voted by a Federal grand jury that they conspired to deprive the Government of their unbiased services in considering a \$7,000,000 governmental problem.

The Government rested its case Tuesday after presenting evidence intended to show that Daugherty and Miller split, with the late John T. Kfir, Republican national committeeman, a \$391,000 "fee" which caused them to award to Swiss claimants the \$7,000,000 assets of the American Metals Company, a German concern, seized by this Government as alien property during the war.

BELIEVE MANIAC MURDERED CHILD

Handkerchief Is Clew in Liberty (Ind.) Case.

LIBERTY, Ind., Sept. 29.—Belief that 8-year-old Eva May Drock, was murdered by a maniac, was strengthened today by information in possession of E. R. Beard, Union County coroner.

Near the spot where the girl was discovered in a thicket near here, dying from wounds inflicted by her assailant, a handkerchief was found. Beard said the marks on the handkerchief were traced to a Cincinnati laundry and found to be those used for an insane hospital at Cincinnati.

Since discovery of the crime the search has centered about attempts to tell a woman seen near the scene, who appeared to be demented, according to persons who observed her actions.

'BLACK EYE' FOR CITY IS FORESEEN

Rucker Says Barret Fund System Must End.

A bankrupt city treasury with a low national credit rating for Indianapolis is viewed by Corporation Counsel Alvah J. Rucker as a probability unless the system through which the Marion County treasurer pockets Barret law interest funds is abandoned.

"Eventually some high court will rule that the city owes hundreds of thousands of dollars to bondholders and other taxpayers," Rucker said.

"Confusion in finance will result to such an extent that Indianapolis will have a black eye all over the country."

Rucker and two taxpayers now are suing for appointment of a receiver for funds of the county treasurer's office in their effort to end the system through which the holder of that office makes more than President Coolidge.
