For three years Mrs. DeWitt had accompanied her son to and from school at morning, noon and night. While returning Tuesday afternoon from school, four blocks from the DeWitt home at First Ave. near Churchman Ave., the boy ran away from his mother's grasp.

**Darts Across Street**  
Dashing across the street at Alton St. and Second Ave., Joseph was struck by a machine driven by Claude Regan, R. R. 5, Box 37. Regan, held by Corporal Paul F. Robinson, declared he swerved in an effort to avoid striking the lad. But his effort was futile.

**Always Feared Tragedy**  
"I have always been afraid some thing would happen to him," said Mrs. DeWitt.

Teddie, an airdale dog, which has been Joseph's pet for eight years, joined James DeWitt, the father, and the grief stricken mother, in mourning the boy's death.

"Teddie and Joseph always were inseparable. Teddie whines around and refuses to eat anything. He seems to understand something is wrong," said the father.
