## CHICAGO NOW IN MAN HUNT OF HOOSIERS

Waiter Declares He Saw  
Two Who Disappeared  
With Officers.

## MIDDLE WEST ACTIVE

Quest for Deputy Sheriffs  
of Tippecanoe County  
Broadens.

CHICAGO, Feb. 11.—Samuel Baxter and John Burns, convicts missing as have been two Tippecanoe County (Ind.) deputy sheriffs since a trip to the Indiana Reformatory at Pendleton was started Tuesday, are believed to be in hiding here, and a squad of detectives is searching the southwest section of the city.

The crew here was provided this morning by a waiter who said two men who were in the restaurant where he is employed resembled the missing convicts. He later identified pictures as those of the wanted men. He said they entered the place after alighting from an automobile.

Search for Deputy Sheriffs John P. Grove and Wallace McClure had been extended over the entire Middle West today. A blood-stained coat found on a road a mile and a half west of Lebanon, Ind., may be a clue to the missing officers.

Two leads Friday proved without foundation. One was a letter purporting to be from the prisoners, saying the bodies of Grove and McClure were in a quarry near Kokomo, but search revealed nothing, as did investigation that the two officers had been found tied to a tree in Clinton County.

Sheriff C. M. Johnston of Tippecanoe County has posted a \$50 reward for information as to the whereabouts of Grove and Wallace, and the county commissioners are contemplating an increase of the amount.

## Searchers in Frenzy

LAFAYETTE, Ind., Feb. 11.—Searchers for Deputy Sheriffs John P. Grove and Wallace McClure doubled their efforts today, frantic at the adhesion of trace of the officers.

The deputies have been missing ninety-six hours, and if the slim hope that they are alive is correct, may be imprisoned in some place, lacking food and water.

Sheriff Johnston believed a note telling him the bodies of the officers would be found in a stone quarry near Kokomo, was a "hoax." Nevertheless, all quarries in Tippecanoe and surrounding counties had their quota of searchers. The Wabash River and numerous little streams were also being dragged.

## Another Crew Fails

## TRAIL WOMAN WHO LEFT BABY

### Hired by Parents to Get Rid of Child, Belief.

Police today were checking the number on a railroad pass to locate a Mattoon, Ill., woman, believed to have deserted the 6-week-old baby found in an automobile in front of St. Vincent's Hospital Tuesday night.

The woman was not the mother of the baby girl, police believed, but probably was hired by youthful parents to "get rid" of the child.

The woman spent the day at Union Station with the infant, where her conflicting stories aroused suspicions of Policewoman Mrs. Anna Bruner and Miss Nora Russell and Margaret Bulman, matron.

Questioned by Mrs. Bruner and Miss Bulman that morning, the woman said the child was hers and that she was on her way to Charleson, Ill.

Later Miss Bulman saw the mother give the child whisky and water from a bottle in another part of the station. Asked when her train left, she said, "Right now," and left hurriedly.

In the evening, when Miss Bulman had gone off duty, Miss Russell saw a young man talk to the woman a few minutes and carry the baby to the train.

When the woman returned several hours later the mysterious woman said the baby had become ill and been left at St. Vincent's Hospital.
