

CEMETERY LOT SALE IS HALTED IN TWO STATES

Injunction Plea Is Filed in Circuit Court Against Glen Haven Group.

Legal action in two States today tied the hands of Glen Haven Cemetery Association, Inc., in its efforts to establish a burial ground on Kessler Blvd., north of Broadmoor Country Club, northwest of the city.

A petition for an injunction prohibiting development of the ground was filed in Circuit Court late Monday by Mr. and Mrs. Earl R. Cox, living near the cemetery site. They allege their property would be depreciated \$2,500 if the cemetery were established.

The other action was an order of the Michigan Securities Commission at Lansing, to salesmen to temporarily surrender their licenses to sell real estate in the cemetery, with the threat they will be cited if they fail to do so.

Salesmen have been very active in the sale of "founders' lots," wholesale sections of the land, to Michigan citizens for several months. The Michigan commission began an investigation several weeks ago.

The Cox suit cites the city ordinance prohibiting establishment of a cemetery within 1,000 feet of park property, points out that Glen Haven borders on Kessler Blvd., park property, and alleges Glen Haven officials have announced intention to proceed with actual development.

Circuit Judge Harry O. Chamberlain set aside the application for a temporary injunction for 10 a. m. Saturday.

Establishment of the cemetery has been resisted since the first announcement of the project as the Mt. Moriah Cemetery Association in 1925. City council voted to repeal the ordinance prohibiting cemeteries along park property in 1926, but before Mayor John L. Duval could act on it four councilmen who had voted for it wrote a letter to Duval, saying they had become convinced the cemetery was a promotion affair and they desired the measure returned. It died there.

Later the project was reorganized as the Glen Haven association and the sale of "founders' lots" instead of stock devised. The Michigan commission has been informed that about \$225,000 worth of "founders' lots" were sold in that State and that some prospects were told they

could realize as much as \$54,000 on a \$300 investment. Glen Haven officials here say no such statements were authorized, and contend that their proposition is entirely legal.

The Michigan order was based upon an opinion of Emerson R. Boyles, deputy attorney general, reading:

"I would recommend that unless the Glen Haven Cemetery Association voluntarily surrenders its license as a real estate broker, the association should be cited before the commission at once, to show cause why such license should not be revoked."

"I further would advise that, so far as possible, its brokers in Michigan be advised not to dispose of any further holdings in this association until the matter is determined fully."

"If it can be established that its brokers have sold these holdings in Michigan with full knowledge of the facts, or if any further sales should be made, such brokers also should be cited before the commission."

DANCE STEPS SHOWN BY BILLY SHARP

Dancing may change its form of presentation and be dressed up till it is hard to distinguish, but the steps used by old time tap and eccentric dancers are still able to hold their own.

This was demonstrated to me yesterday when I saw Billy Sharp and company. There were two young fellows in the act that did the modern tap steps. This involved getting a little closer to the floor and knowing some acrobatics. These two men were good dancers, there is no doubt to that, but Billy Sharp revived the steps that made the old time minstrels.

The steps of Pat Rooney, Eddie Leonard and George Primrose were done by Sharp and then he did one of his own. This was all straight tap dancing and it was good.

In this same act, was Mlle. Mariomne who did some semi-classical dancing and a number on her toes. A charming dancer. There are two others in the act, a singer who was very fair, an accompanist, a good dancer and song revue.

LOOKING OVER THE BURLESQUE

There are several good things in the show in the way of skits that were high class. There was dancing and singing that, although it was burlesque, was cleaned up considerably. But I failed to note that it had lost any of the kick.

There were two song teams that made a hit. The first was two girls from the chorus that had a song and dance act. They were fairly good. The second was composed of one of the women principals, the juvenile and the second comedian. They sang several songs in "barber shop" harmony that were good.

Frank Harcourt was the leading comedian and Vivian Kent and Billy Emerson were the female leads. This is fairly good burlesque without all the "dirt."
