

COPS BREAK UP 'FAMILY PARTY'; ARREST SEVEN

Child Neglect Charges Are Lodged; Confiscation of Booze Claimed.

When police went to a residence at 36 West Thirtieth street early today to serve juvenile court warrants on Mr. and Mrs. Thomas Campbell they interrupted a "family party."

As a result seven persons are held on charges of contributing to child neglect, and Ben Fox, formerly of Elwood, living at the address, is charged with operating a blind tiger and contributing to child neglect.

Police were seeking the Campbells following release of Fox and Mrs. Campbell Tuesday afternoon on blind tiger charges. Campbell has fled the city, and his wife, Doris, according to police, went to Chicago immediately after her release in municipal court.

Armed with warrants charging the Campbells with child neglect, Sergeant Harley Jones and Patrolman Harry Thayer heard sounds of merriment issuing from the apartment when they approached the door.

They rapped, once, twice and three times and the sounds ceased. After threatening to batter down the door, the officers were admitted by Frank Reilly, 34, of 3032 Washington boulevard.

Police said they found the Campbells' children, 4 and 5, asleep in another room. They were taken to the detention home. Confiscation of a small quantity of liquor also was claimed by police.

In addition to Reilly and Fox, those arrested were: Mrs. Margaret Markey, 23, of 4431 Clifton street; Mrs. Hazel Braun, alias Cuffel, 33, R. R. M. Box 43; Miss Helen Porter, 24, of Tipton; Albert Nickerson, 22, of 1913 North Meridian street; Herman Irvington, alias Ringling, 46, of 1503 North Pennsylvania street; and Robert Blont, 22, of 1450 College avenue.

Two roomers, peacefully asleep amid the hilarity, were not arrested.

Fox told police: "We had the children put to bed early and we were just having a family party." Four hundred and fifty empty gin, ale, beer and whisky bottles were found, police said.

Fox and Mrs. Campbell were released Wednesday on blind tiger charges after police had the wrong address on a warrant.

Blind tiger charge against Fox was continued until April 9 by Municipal Judge Clifton R. Camer on today.



Russian, American Meet in Immigration Debate

Immigration laws as they affect the United States was the subject of debate Wednesday night at Indiana university, Bloomington, between Maurice G. Hindus, Russian author, and Lothrop Stoddard, Massachusetts writer.

Stoddard, writer of the recent book, "The Master of Manhattan—A Life of Richard Croker," took the affirmative of the subject, "Resolved, That immigration laws discriminating in favor of North European immigration as against east European immigration are advantageous to the United States."

ORAL ARGUMENTS IN SHIPP SUIT BEGUN

Townships Infringed Ventilating Patent, Is Charge.

Oral arguments were heard today by Federal Judge Robert C. Balter in the patent suit of C. E. Shipp, manufacturer of ventilating units of Indianapolis, against three townships in Montgomery county for alleged appropriation and use of his patented radiator box.

Judge Balter ordered attorneys for both sides to submit briefs of facts in the suit on April 4.

The suit charges township officials with permitting Herman F. Zietlow to install a radiator box in the high school at Newmarket, Ind., which is the replica of the box patented in 1929 by Shipp.

PAY HIKE ASKED BY STREET CAR WORKERS' UNION

Public Service Group May Get Wage Dispute for Arbitration.

For the third time since 1928, the public service commission may be called upon to sit as an arbitration board in a wage and working conditions dispute between employees and management of the Indianapolis Street Railway Company.

In bringing such matters before the commission twice before, the employees succeeded once in obtaining a wage increase and the company stand was upheld the second time.

A new petition of grievances has been filed by the union workers of the company with the superintendent. When and if he disapproves the move, it will be served on the president of the company and from him appealed to the public service commission, it was announced to

day by J. S. Fenstermacher, union attorney.

James Green is president of the union and claims that about 50 per cent of the car men belong.

Procedure to appeal to the public service commission is set out in a contract signed by all workers. This contract does not recognize the union.

In addition to asking wage increases from the present 40 cents to a 60-cent hourly minimum, the petition asks that the right of collective bargaining be recognized and that the company and union appoint their own board of arbitration.

It also would require the company to issue passes to workers and to re-employ those discharged for striking in 1928.

Little hope is held for the wage increase at this time, but the right of collective bargaining and other elemental labor rights may be acted upon favorably by the commission arbitration board, it was predicted.

ROAD WORK SPEEDED

Nation Prepares Greatest Building Program.

WASHINGTON, March 26.—The greatest highway construction program in the history of the United States is being undertaken this spring, it was revealed today at the bureau of public roads of the department of agriculture.

Latest available figures show 4,648 miles of highway construction approved, for a total outlay of

\$105,531,389. This is to be added to the 9,451 miles costing \$237,094,945 now under construction.

About half of this money is provided by the federal government.

There is a balance of \$103,360,973 still to be assigned to projects as they are approved, which would be matched by state funds to provide about twice that amount to go into the actual construction.






