

NOLAN CLEARS CWA OF GRAFT

Has No Evidence to Give U. S. Grand Jury, Says Prosecutor.

The government has no evidence concerning graft in the CWA personnel to present to the federal grand jury when it convenes Monday, Val Nolan, United States district attorney, said today.

Although federal investigator are delving into cases of alleged graft in CWA work in the state, the district attorney has received evidence on but one case.

The evidence on this case is insufficient to present to the jurors, Mr. Nolan said.

This case, investigated by federal authorities in Indiana, concerns an official who is alleged to have used his office to obtain for a CWA job another person, and then to have taken part of the salary.

The national division of investigation of the PWA increased its staff to 130 members early in February due to widespread reports of irregularities throughout the country.

No PWA investigations have been conducted in Indiana, although the CWA organization has come under scrutiny of federal investigators.
