

HAYNES JUST ANOTHER HEAVYWEIGHT, COL. JOE DECIDES

Negro Gets Technical Kayo When Carnera's Exhausted Dogs Refuse to Carry on

Old Satch's Puppies Collapse Under Strain of Toting 265 Pounds Through Nine Rounds; Winner Disproves He Is Heavy Slugger by Failing to Floor Huge Italian.

NEW YORK, May 28.—The official explanation was that Primo Carnera had suffered temporary paralysis of the left leg and for that reason his bout with Leroy Haynes had been stopped in the ninth round, with the Negro a winner by a technical knockout, all this transpiring last night at Ebbets Field.

But what probably happened was that Carnera's dogs, or feet, unaccustomed to lugging the 265-pound superstructure around for more than three or four rounds at a time, grew weary of their burden and just quit. Although Carnera's dogs are far and away the largest in captivity and not unused to heavy trucking, there is a limit beyond which even they can not go.

And so as the bout progressed, if progress is the word, from one round to another and still another, Carnera's dogs began to bark and howl. There were times when their anguished cries reached such intensity that the good people of Flatbush slammed their windows shut and gathered their terrified brood to their bosoms.

At the close of the eighth round the more sensitive animal lovers at the ringside started to make audible protests to the S. P. C. A., which is, I am told, an organization designed to protect dumb beasts from merciless treatment on the part of humans. It was evident at this point that Carnera was taking shameless advantage of the loyalty of man's best friend.

He was swaying and tottering at the end of the round and the task of ferrying him back to the corner was one that called for horse power. But by some miracle understandable only to those who appreciate canine fidelity, Carnera's dogs managed to get him there.

But he insisted they fetch him out for the ninth, which was next to the last round, and amid much groaning and suffering they got him to the middle of the ring, where they collapsed, utterly exhausted, their tongues hanging over the tops of Carnera's shoes, a dry pasty gray from fatigue.

To be precise, forty seconds of the round had passed when Carnera, without being hit, suddenly began to fold like a mammoth tent. Dragging his left leg, he staggered over to the ropes. An examination revealed the muscles in his leg from knee to ankle had become knotted. It was here referee Arthur Donovan stopped the fight and declared Haynes the victor.

So many curious episodes have threaded Carnera's ring career that this unusual climax moved the evil minded to sinister murmurings since it plainly was more desirable for future matches for Haynes, coming up, to win than Carnera, going down.

Also, there was the growing rumor that one of Carnera's managers—Bill Duffy—had something more than an academic interest in Haynes. But I am disposed to dismiss this as the product of poisoned minds since the time Carnera's dogs quit.

Haynes, the only one who could have benefited by a pilot had been pretty well exposed as just another heavyweight.
