

### REBEL PROCLAIMS NEW GOVERNMENT

#### Revolt Leader Contends Left Wing Rule Has Disintegrated.

GENERAL HEADQUARTERS, SPANISH REBEL NORTHERN ARMY, July 24.—Gen. Emilio Mola, rebel leader in the north, proclaimed a new Republican government in Spain today, contending that the Left Wing government has disintegrated.

As Mola issued his proclamation from Burgos, his temporary headquarters, wireless advised told of chaotic conditions in San Sebastian, with Americans and other foreigners in grave danger.

Gov. Landon railed the New Deal with his fire. He charged failure to cope with unemployment. He warned that "crushing debts and taxes" must retard prosperity and jeopardize the people's rights. He charged that many desirable liberal objectives had been "discredited during the last three years of cagey thinking, unworkable laws and incompetent administration."

His speech was an indictment of Roosevelt's record on charges of bad administration and failure to realize its opportunities.

"It must be kept in mind," he said, "that the security of all of us depends on the good management of our common affairs."

A phrase by Gov. Landon aroused quick speculation whether he intended drafting some prominent Democrats for his Cabinet or other high Federal posts in event of his election next November. He had promised to conduct an efficient government, and added: "I shall call to my aid those men best qualified to conduct the public business—and I mean just that."

Gov. Landon leaned far over the rostrum to bark those final words at his audience. A few hours earlier he had been asked whether Democrats would be included in a Landon Cabinet.

He was remanded in custody for one week.

Sir Donald Bradley Somervell, attorney general, prosecuting in person, told the court that McMahon had said:

"I wish I had done the job properly. I could easily have shot him. It would have been better if I had shot myself."

Might Name Democrats

Observers interpreted his cryptic remark to mean he would invite Democrats to join him in Washington if they were better fitted for a particular job than any available Republican.

That was the tax spending economy philosophy of the "Kansas Coolidge," who stood there last night in the glare of the klieg lights with his voice rolling across a continent because he had balanced the budget of his state.

A barmaid, Sir Somervell said, would testify later that at a public house near Buckingham Palace, McMahon said the day before his attack: "I am going away. You'll never see me again."

The Rodefied Co., wholesale Zentz radio distributor in central Indiana and parts of Ohio, has obtained a long-term lease on the three-story building at 126-128 Kentucky-av., real estate company plans to move from 5 W. North-st. Aug. 1.

Approximately 10,000 square feet of space on the first floor of the National Automotive plant, 22d and Vanders-sts, has been leased to the Capitol City Supply Co., Inc., the Brennan company reported.

The Alben Coal Co. is to be local distributors for Sinker-Davis Fire King stokers, and expects to be in operation at the plant by Aug. 1.
