

# THANKSGIVING SERVICES TO BE HELD WEDNESDAY AND THURSDAY

## Indianapolis Church-Goers to Attend Independent and Union Meetings for Worship

### Influence of Preaching Mission Expected to Boost Attendance This Year to 10,000, Federation Officer Says.

More than 10,000 church-goers are to join in union Thanksgiving services in 39 Indianapolis churches Wednesday night and Thursday. Members of 114 churches are to take part in services, sponsored by the Indianapolis Church Federation, according to Dr. Ernest N. Evans, executive secretary.

Dr. Evans said he expected programs this year to attract more people than any similar ceremony in the past. Interest has grown, he pointed out, due to the Preaching Mission in approximately 100 Indianapolis churches.

About 500 persons are to take an active part in services, Dr. Evans said, including pastors, musicians and singers.

Union Thanksgiving services have been sponsored by the Indianapolis Federation for more than 10 years. Churches in every section of town are to participate.

Eighteen churches are to hold individual services. All Episcopal Churches are to take part in services in Christ Church, Monument Circle, Thursday. Among the larger groups are the University Park Christian Church, with 11 others uniting; the Roberts Park Methodist, where eight churches are to meet, and the Woodlawn Park, where 12 other churches are to participate in services. At the Forty-Ninth Street Christian Church, where the Rev. Glenn Reynolds is to preside the North Baptist, Bellaire Methodist, and the host church are to hold services Wednesday night.

Among other services Wednesday night are the Broad Ripple Christian, Cavalry Baptist, Roosevelt Temple Methodist, University Heights United Brethren, Unity Methodist Protestant, Broadway Methodist, Friedens Evangelical, and St. John's Evangelical, and West Washington Street Methodist Churches.

The Rev. W. E. Gillett is to speak at the Broad Ripple Methodist Church, which is to unite with the Church.

**Brightwood Program**

In the Brightwood District, the Calvary Baptist sermon is to be given by the Rev. William O. Breedlove, the church uniting with the Brightwood Methodist Church.

At the Roosevelt-Temple Methodist Church, Dr. Charles M. Phillips, Hillside Christian pastor, is to preach.

Three groups, University Heights Christian, Madison Avenue Methodists and University Heights United Brethren are to hold services Wednesday night in the United Brethren Church. The Rev. J. Shields White, Madison Avenue Methodist Church pastor, is to speak.

The Rev. Harvey J. Kaiser, Riverside Park Methodist pastor, is to give the sermon Wednesday when his church joins with the Union Congregational and the Unity Methodist Protestant Churches.

**Other Wednesday Services**

Five individual services conclude the schedule of Wednesday night services. Dr. Richard D. Millard is to preach at the Broadway Methodist Church. Others include sermons by the Rev. Robert C. Kuebler, Friedens Evangelical, the Rev. John S. Albert, Gethsemane Lutheran, the Rev. Ernest A. Piepenbrok, St. John's Evangelical, and the Rev. H. L. Overde, West Washington Street Methodist Church.

Among the Thursday morning services are the Roberts Park Methodist Church, where Dr. Logan Hall, Meridian Street Methodist pastor, is to preach to members of the First Baptist, First Evangelical, Merritt Place Methodist, New Jersey Street Methodist, Meridian Street Methodist, Second Presbyterian, Central Christian and Roberts Park Churches.
