## MUTILATED BALLOTS ARE FOUND AT GARY

Contest Held Likely in Both Parties.

CROWN POINT, May 11 (U. P.).—Wholesale contests in both Democratic and Republican primary results appeared likely today following the discovery of 336 mutilated ballots in three Gary ballot boxes used in the primary election.

Circuit Judge T. Joseph Sullivan and three members of the Lake County Board of Election Commissioners reviewed the situation last night and will meet again Saturday to take further action.

Charles Baran, Democratic member of the county commission who was defeated after four terms by Walter Landier, German-American of Gary, said he might ask Judge Sullivan to throw the entire election out.

On the Republican side, John Davies of Gary, who lost to James H. McShane of Hammond for the nomination as county treasurer, indicated he might contest the election.

The final tabulations gave McShane 9418 votes and Davies 9177. The tally sheet for the 22d precinct, Mr. Davies' home district, showed him with 134 votes and Mr. McShane with 119. Mr. Davies claimed, however, that the certificate of memoranda for the precinct gave him 375 votes as compared with 119 for Mr. McShane, a difference of 241 votes in the two reports.

It was reported the Federal Government might enter the investigation because the election involved Rep. William T. Schulte.

The mutilated ballots were discovered by Horace Broker, employee of the County Highway Department and a Baran appointee. The discovery was made as the ballot boxes were being stored until the November election.

Election Board members Walter Zurborgen, Chairman, J. Hiram Johnston, and Walter Mybeck said every candidate on the county Democratic ballot is affected.

## CANTON DEATH QUIZ REOPENED

Slain Woman's Husband Held After Note Claims Killers Paid.

CANTON, O., May 11 (U. P.).—Police held Dueber S. Cable, moneyed contractor, on an open charge today as they revealed that a suicide note left by his paramour, Mrs. Theresa Ludwig, charged that the killers of Cable's wife, Rose, were paid \$200 for slaying her.

Mrs. Ludwig's letter said the killers were from Cleveland, authorities announced.

The suicide of Mrs. Ludwig Monday at Conneaut, O., served to reopen the case 14 months after the Sunday school teacher-socialite was killed by a shotgun blast fired through a window as she put her canary to bed.

Both Mrs. Ludwig, plump 46-year-old divorcee, and Cable had been held for questioning at the time.

Attorney W. B. Quinn, counsel for the divorcee during last year's investigation, said he had received the suicide letter, addressed to him, from a relative of Mrs. Ludwig. He turned it over to Stark County Prosecutor A. C. L. Barthelme.

Police Chief Ira Manderbaugh expected to confer with a brother-in-law of Mrs. Ludwig, in whose Conneaut home she had been living since the slaying and where she killed herself by inhaling carbon monoxide fumes from her automobile.

Mrs. Ludwig's note was about 300 words in length. She said that at first she never thought she could tell what she related, "but I could not get it off my mind."

**INLAND STEEL MOVES TO STOP NLRB ACTION**

CHICAGO, May 11 (U. P.).—The Inland Steel Co. acted today to block the National Labor Relations Board's plan to set aside and vacate its order for a signed contract between the company and the C. I. O.

The Board filed notice of its intention yesterday and set Thursday for reopening of proceedings. Inland attorneys, who had filed an appeal from the order, charged that the Board had no right to vacate it.

The attorneys filed an answer with what right it can vacate the order. The answer charged that if the Board has the right to set aside the order it has no right to hold further proceedings.
