## EX-RAILWAY AGENT FACES FRAUD TERM

DETROIT, May 22 (U. P.).—James A. Wilson, 58, former general claims agent of the Grand Trunk and Western Railroad, was held under \$10,000 bond today after a federal court jury found him guilty of using the mails to defraud the road of \$75,000.

Wilson was referred to the probation department pending sentence. The government charged that Wilson, Oliver T. Prickett, Lansing, Mich., former claims agent for the road, and Perry R. Chapin, Hammond, Ind., attorney, conspired to defraud the railroad of \$75,000 by preparing and approving 17 false damage claims arising from an accident near South Bend, Ind., Nov. 12, 1938.

Prickett and Chapin pleaded guilty and now are awaiting sentence. Prickett appeared as chief government witness against Wilson.

## List 245,712 in In City Directory

THE LARGEST city directory in Indianapolis history was ready for distribution today.

R. L. Polk & Co. announced that this year's volume has 245,712 names in the city and five suburbs. This is an increase of 4944 names over last year. The directory contains 2314 pages, 53 more than in 1941.

Here are three important instructions in case of an air attack:

1. Do not shut off main gas valve, or any of your appliances.
2. Only if your gas supply is interrupted should you shut off your main gas valve, located near your meter. Do not attempt to relight any of your appliances, but telephone the gas company.
3. If you smell gas, or think there is a gas leak, turn out all lights to preserve blackout conditions, then open your windows, go to the nearest telephone and report this condition to your gas company.

## UPSTATE MERCHANT IS GRANTED RETRIAL

VALPARAISO, Ind., May 22 (U. P.).—Frank Schneider, Hammond merchant convicted and sentenced on a charge of filing a false claim for \$4900 against a Lake county township relief fund for goods the state claimed was undelivered, will be retried Sept. 14 because of new evidence discovered in the case.

Porter Circuit Judge Charles W. Jensen granted Schneider a retrial yesterday when the Lake county auditor's office reported finding a delivery slip for the goods, consigned to a Hammond WPA sewing project, which bore the signature of an employee of the township trustee's office.

Schneider was convicted in May, 1940, and sentenced to a two-to-14 year prison term in state prison. His conviction was upheld last month by the Indiana Supreme court, which denied an appeal by Schneider.
