NAVY'S BUDGET NEEDS REDUCED

Roosevelt Asks Congress
For \$23,719,153,050
In '46 Fiscal Year.

WASHINGTON, March 13 (U. P.).—President Roosevelt asked congress today for a 1946 fiscal year budget of \$23,719,153,050 for the navy. This is a reduction of more than \$4,000,000,000 from the figure for this year.

The President also submitted a request for additional contract authorizations of \$3,068,012,624 for the navy. About half of this, or \$1,513,012,624, would be new authorizations. The balance would be continued from the current fiscal year.

The request envisioned a navy during fiscal 1946 composed of approximately 3,389,000 men. Marine corps strength was set at 478,000 and the coast guard strength at 173,165.

Ship Estimates Cut.

The request indicated that the U. S. high command envisions full-scale naval operations in the war for at least another 16 months. The 1946 fiscal year ends on June 30, 1946.

Total appropriations for the navy in the 1945 fiscal year were about \$28,500,000,000. In 1944 the total was about \$23,000,000,000.

The White House said principal reductions were approximately \$2,000,000,000 in previous estimates of the cost of the navy airplane program and a drop of about \$4,000,000,000 in cash required for shipbuilding.

These reductions were partially offset by "increased requirements for advanced bases" and by certain increases in pay allowances, dependent allowances and higher ratings achieved as the war progresses, the White House said.

INJURED MOVIE ACTOR SUES FOR \$80,000

HOLLYWOOD, March 13 (U. P.).—Movie Actor Keenan Wynn decided today that injuries he received in a traffic accident Sunday were worth \$80,000.

Wynn, 28-year-old son of comedian Ed Wynn, filed suit for that amount against Mrs. Verne B. MacLoney, driver of the car that collided with Wynn's motorcycle.

The actor suffered a fractured jaw and severe head and back injuries. Hollywood hospital attendants said he was "resting comfortably."

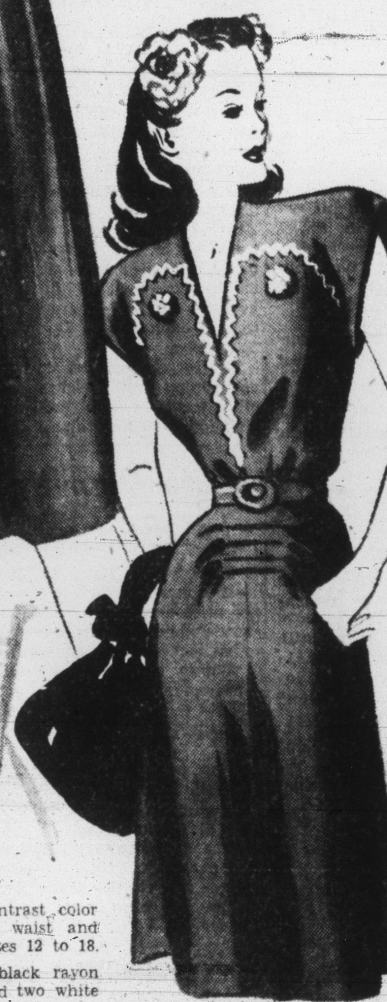
