GATES DELAYS NAMING JUDGE

Hints Appointment Won't Be Made Before Next Week.

Governor Gates indicated today that his appointment of a new judge of Municipal court 4 will not be made before next week.

He did not indicate which way he intends to go in the apparent deadlock between factions of the Marion county Republican leadership over candidates for the judgeship.

The war veterans' division of the G. O. P. has brought widespread pressure for the appointment of an ex-service man to the post.

A delegation of veterans headed by Cale J. Holder called on the governor yesterday, urging the appointment of a veteran. They have suggested Lawrence H. Hinds, George House and Alex M. Clark, who was defeated for the G. O. P. prosecutor nomination.

Sided With Veterans

County Chairman Henry E. Ostrom has sided with the veterans, recommending that the governor appoint Mr. Clark.

Joseph J. Daniels, 11th district chairman, has recommended the appointment of Paul C. Wetter, Beech Grove magistrate court judge and 13th ward G. O. P. chairman. This recommendation was reportedly based upon a commitment made during the primary election campaign.

Up to today, no compromise had been reached on the appointment. The Municipal court 4 bench will be vacated Jan. 1 by Judge John Niblack when he becomes judge of Superior court 1.

HOOSIER BECOMES DEAN AT HARVARD

CAMBRIDGE, Mass., Nov. 26 (U. P.)—Dr. Wilbur J. Bender, former veterans' counselor at Harvard university, succeeded Dr. A. Chester Hanford, the university's longest tenured dean, today following Dr. Hanford's resignation to become professor of government.

Dr. Bender, a native of Elkhart, Ind., was formerly an assistant dean at Harvard. He served as a lieutenant in the navy during the war.

2 CONVICTS GIVE UP AT LEBANON

3d Pendleton Escapee Still At Large.

LEBANON, Ind., Nov. 26.—Cold and hungry, two Pendleton reformatory escapees surrendered to Boone county authorities at midnight last night.

The convicts are Richard Tracy, 24, Gas City, Ind., and James Rose, 28, Indianapolis. The two walked away from the reformatory with a third prisoner, Thomas Evans, Wheatland, Friday. Tracy and Rose both were serving time on charges of second-degree burglary. Evans still is at large.

At midnight yesterday the men walked up to a farm house at state roads 49 and 29 and asked the farmer to call the sheriff.

Slept in Corn Cribs

The arrests were made by Sheriff Frank McCormick and Rush L. Robinson, deputy sheriff. The pair said they had lived on clams and

wild turnips and slept in corn cribs.

They said the weather made them so uncomfortable that they were making their way to Pendleton to surrender. Tracy said he didn't know what prompted them to make an escape as he had but a few months before becoming eligible for a clemency plea.

The men still were wearing their Pendleton uniforms when arrested. Tracy said that they had lived in constant fear of capture. One night, he said, he imagined he heard sirens and came out of hiding to give himself up.

FIVE ESCAPE INJURY IN TWO-CAR COLLISION

Five persons escaped injury in a two-car crash on Road 52 at the 30th st. intersection this morning.

INDIA'S COALITION NEARING COLLAPSE

LONDON, Nov. 26 (U. P.)—The India office announced today that Viscount Wavell, viceroy of India, would return to London late this week for consultations with the British cabinet.

The announcement was taken to mean that efforts to promote a coalition government in India had failed.

New Delhi sources said Lord Wavell had sent an urgent appeal to London for instructions in handling the current Indian political crisis.

Lord Wavell's appeal was said to have followed receipt of a formal letter from Pandit Jawaharlal Nehru demanding the resignation of Moslem league members from the interim government.

Mohammed Ali Jinnah, president of the Moslem league, has notified Lord Wavell that Moslems will not attend meetings of the constituent assembly scheduled to open Dec. 9.


