Fear All 51 Lost In Shipwreck

KETCHIKAN, Alaska, Nov. 26 (UP)—Search parties reported "no sign of life" around the severed bow of the Army freighter *Clarksdale* Victory today.

It was believed that all 51 crewmen perished. The stern of the ship broke away and slipped into the Pacific Ocean off the British Columbia coast Monday night.

Lt. Cmdr. Fred J. Schreiber, leader of the search, reported by walkie-talkie radio from tiny Hippo Island that the grounded vessel had cracked in half under 50-foot waves whipped by high winds.

But Cmdr. Schreiber scheduled a thorough search of the island today on the remote chance of finding survivors.

His group of Alaska-based coast guardsmen were spurred by the report of a search pilot yesterday that three figures were sighted on the beach near the broken bow.

The three figures could have been native of nearby Graham Island, it was said.

A search of the island during the night failed to locate any survivors.

Court Weighs Alimony For Rubinstein's Wife

NEW YORK, (UP)—Justice Lloyd Church of New York Supreme Court reserved decision today on Mrs. Laurette Rubinstein's separation suit asking \$100,000 alimony annually from her husband, Serge Rubinstein, who is serving a 2½ year sentence as a draft dodger.

Rubinstein filed a 33-page affidavit, drawn up at the Federal penitentiary in Lewisburg, Pa., charging that his wife wanted the separation because she feared she would be deported with him after he serves his time.

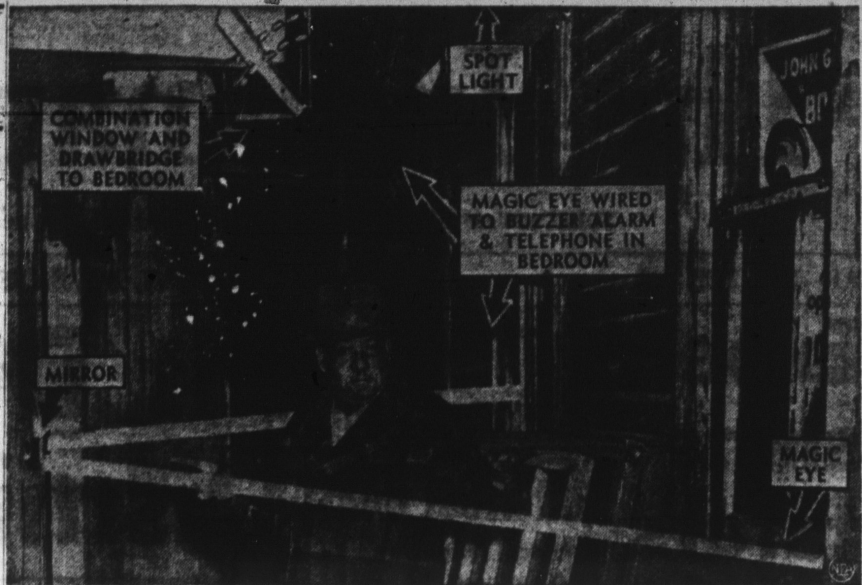

Alabama Withdraws Warrant for Fugitive

MONTGOMERY, Ala., Nov. 26 (UP)—Ten years of reform and model living paid off today for James R. Collins, 38, who became a respected citizen of Doylestown, Pa., after escaping from the Alabama prison, where he was serving a life sentence.

Gov. James E. Folsom yesterday withdrew a fugitive warrant against Mr. Collins and left the reformed man free to come to Alabama to seek a full pardon from the state pardon and parole board.

Frank Boswell, state prison director, recommending withdrawal of the warrant, said "the environment of a prison is no place for a man like that."

"The boy has undoubtedly made good," Mr. Boswell said. "He has made good friends, established a business and behaved like a good citizen."

Gang Leader Executed

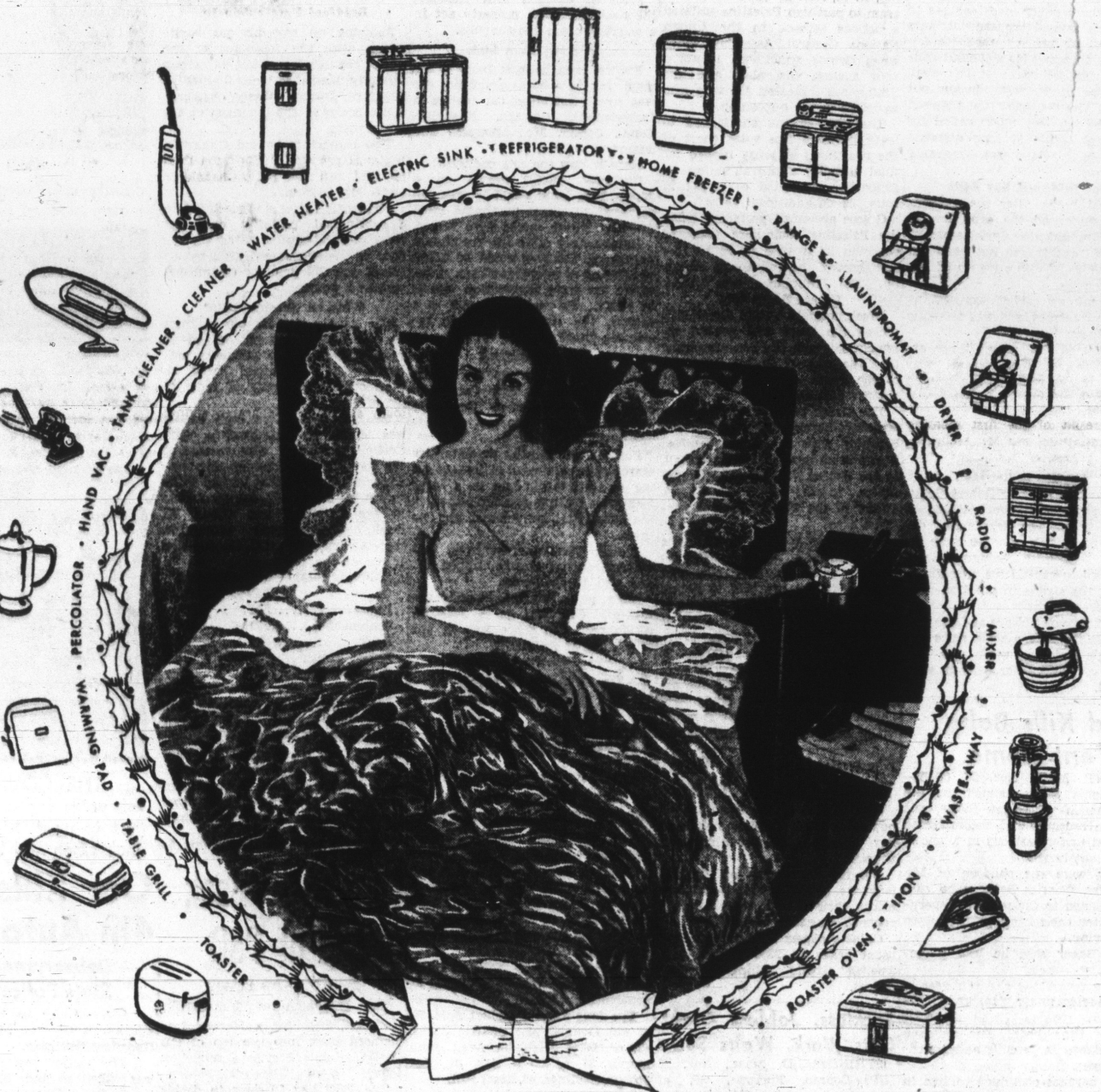
In 1928, when Mr. Collins was only 17, he was given a life sentence for acting as "lookout" for a gang that robbed a bank in Clanton, Ala.

The leader of the gang, who shot the bank president to death during the holdup, was electrocuted soon after the robbery and slaying.

In 1936, Mr. Collins fled the prison and disappeared. Several weeks ago he was rearrested in Doylestown, traced through correspondence with his aging parents, Mr. and Mrs. W. E. Collins of Mobile, Ala.

In the meantime Mr. Collins had settled down in Doylestown, developed a contracting business, married, became the father of two children and established himself as a substantial citizen.

Gov. Folsom said he had received numerous letters in Collins' behalf from "some of the best citizens" of Pennsylvania.
