Among Requirements for Wooden's Successor

**HELP WANTED—Male or female.**  
Immediate job opening in county welfare department for any  
applicant who can qualify. Must have background in social work  
bookkeeping and administration. Diplomatic experience helpful.  
That's the kind of an ad the County Welfare Board might run  
to find a successor to Arthur E. Wooden, deposed county welfare  
director.

wanted to give a true picture of  
what the applicants were getting  
into—it might add a few more  
lines reading:

### List Qualifications

"Candidates must be able to get  
along with professional social  
workers with spendthrift notions  
and budget-minded business men  
with opposite leanings. Tight rope  
walking experience and ability to  
carry water on both shoulders  
considered assets."

### Army Officials Agree

#### Segregation Will End

WASHINGTON, July 30 (UPI)—  
Army officials agreed with  
President Truman today that  
segregation of Negro and white  
troops eventually will be elim-  
inated.

But for the present, they said,  
they are going to continue their  
long-established practice of putting  
Negro enlisted men in sep-  
arate companies.

Mr. Truman told a press con-  
ference yesterday that he en-  
visioned an eventual end to seg-  
regation when he issued his re-  
cent order for "equality of treat-  
ment and opportunity for all per-  
sons in the armed services," re-  
gardless of race or religion.

These requirements include:

"Thirteen years out of the last  
15 of responsible full-time suc-  
cessful paid experience in a wel-  
fare agency, a public agency, pro-  
fessional practice or private busi-  
ness organization, of which at  
least five years out of the last  
eight must have been a highly  
responsible administrative or su-  
pervisory capacity involving  
budgeting, selection of personnel

and, last but not least as demon-  
strated by the state-county fric-  
tion that caused the job being vac-  
ant, "ability to establish and  
maintain harmonious relation-  
ships with administrative officials,  
federal and state welfare repre-  
sentatives and the public."

That's the kind of man who will  
be hired for the \$4600 to \$6300  
Marion County welfare job from  
the list of applicants... presum-  
ably, that is, someone applies.
