

'Just Begun To Fight,' Says Truman On Return To Capital

Crowd Hails Arrival at Union Station

President Faces Work-Laden Desk

President Truman returned home from his western campaign swing today, vowing he had just begun to fight.

To a cheering crowd at union station in the nation's capital on hand to welcome him home after an 8300-mile tour—the President said:

"I don't intend to pull my punches. I've just begun to fight."

That also was the substance of the fighting remarks the President made when he returned to the White House.

dent made when he left Sept. 17 on the campaign drive. "I'm not going to give an inch," he said in his battle to retain the White House.

To invade New York

The President returned to a work-laden desk at the White House. But he intends to whip through the accumulation of work in order to start off Oct. 6 on his campaign. Then he will hit the home state of his GOP rival, Gov. Thomas E. Dewey, and Pennsylvania, New Jersey and Delaware.

As Mr. Truman returned to Washington, Gov. Dewey took the 200-mile drive to New York City, with a determined try to win it away from the Democrats.

On the last lap of his own 8882-mile western swing, the New York governor planned nine rest points for talks today as his train crossed Kansas and Missouri.

Gov. Dewey promised again last night in his final major speech of the tour at Cheyenne, Wyo., to keep the government free of Communists if he is elected.

Progressive Party Candidate Henry A. Wallace challenged the GOP to back his Progressive Party candidates against southern California Republican Congressmen who have no Democratic opponents.

The "invitation" in Los Angeles followed the party's announcement it would withdraw from the field against some "liberal" Democrats.

Renews Congress Attack

Mr. Truman kept up his fire on the Republican Congress last night in a major speech at Charleston, W. Va. He bid strongly for the state's heavy coal-miner vote, and told his crowd a GOP victory would mean a "headlong dash into depression."

Gov. Dewey told his Cheyenne audience that "I can assure you that witnesses will not be kept out of the grand jury under a Republican administration and if our laws need strengthening, we will strengthen them."

N. Y. Representative Talks to Women Here

Americans can't have their cake and eat it too, Rep. Katherine St. George (R. N. Y.) told Republican women today in a warning against too stringent an attack on inflation.

"There are only two ways to handle inflation," the Republican congresswoman said. "One is to let it adjust itself through the law of supply and demand. The other is through controls of everything, wages as well as profits."

Speaks at Luncheon
This means regimentation and the eventual climax is the police state. The cure would be worse than the disease."

Rep. St. George spoke at a meeting of Marion County GOP women at a luncheon in the Riley Room of the Claypool Hotel.

She attacked President Truman's policies as illogical, wanting higher minimum wages, more spending, and at the same time lower prices.

She blamed the President for the bickering between the executive office and the 80th Congress and said Congress did the wise thing in "folding their tents and departing in the hope that after Nov. 2 the federal government can go full steam ahead with all hands working in the same direction."

Creighton Talks

Charges Old GOP Machine 'at Work'

Dailey Sees 'Evidence' In Prosecutor Race

The old Republican machine is back trying to recapture control of the prosecutor's office, George S. Dailey, Democratic candidate for prosecutor, charged in a speech in Beech Grove last night.

"The first time I ever heard of my opponent (Frank H. Fairchild) was when he was representing Henry E. Ostrom (former county GOP chairman) in an injunction suit to remove a Republican from the voters' registration board," he said.

"I later learned that he was a Republican ward chairman under Mr. Ostrom and a few months ago my opponent was 'hand-picked' to run for prosecutor."

'Picked by Machine'
"The present control of the prosecutor's office is still in Mr. Ostrom's hands with James W. Ingles (GOP chairman) acting as his proxy. The rest of the gang consisting of the McNulty brothers, Tom and Ed, and J. G. Zazas complete the group that selected my opponent for nomination from the machine's ranks."

Mr. Dailey referred to Mr. Zazas as the GOP worker who recently called on two county clubs for campaign contributions.

"This call was undoubtedly made because of their lucrative income from slot machines," he said.

All Republicans
"My opponent has recently directed criticism at law enforcement. I wonder if he is aware of the fact that the chief law enforcement officer here is the prosecutor who at present is a Republican. The sheriff is a Republican and the criminal court judges are Republicans," he said.

"If there is anything wrong with law enforcement I would like my opponent to explain how any break-down can be attributed to any party except the Republican Party."
