## Evansville Man Held Tax Evader

### U. S. Jury Returns Verdict of Guilty

A federal jury today returned a guilty verdict in the case of an Evansville man charged with evasion of income tax payments totaling \$8645.

In an indictment returned by a grand jury last September, Helen J. Fenwick was charged with concealing income from rental properties, coin-operated devices and a drugstore he owned.

Fenwick faces a maximum \$20,000 fine or 10 years' imprisonment, or both.

#### Use 'Net Worth' Theory

Because there were no records showing Mr. Fenwick's income and expenditures for the years in question, the case was tried under the "increasing net worth" theory.

By this method, the prosecution attempted to prove income by establishing the net worth of an individual for a given year, then showing an increase in worth during subsequent years.

Income tax officials expected the decision by the jury would have repercussions among some professional people and others who may have been lax in keeping records and filing correct income tax returns.

### Former Actress' Jewels Worth \$200,000 Stolen

NEW YORK, Jan. 7 (UPI)—Lisette Vere, former Hungarian actress, reported today that \$200,000 in jewelry has been stolen from her fashionable east end apartment.

She said the jewelry was discovered missing from a closet in the apartment when she and her husband, Erhart, Rugg, a wealthy textile manufacturer, returned from an evening's entertainment.

### U. S. Canadian Forces Plan Giant War Games

WASHINGTON, Jan. 7 (UPI)—The armed services will hold their largest maneuvers since the end of the war from Feb. 14 to April 1 in the western Atlantic and Caribbean areas.

The giant war games will include 100 ships and 35,000 men from the Army, Navy, Marines and the Royal Canadian Army.

(Continued From Page One) accepted an appointment as Undersecretary of Treasury.

#### Didn't Last Long

That job didn't last long, however. He differed with Mr. Roosevelt on fiscal policy and returned to private law practice within six months.

But Mr. Acheson supported Mr. Roosevelt for re-election both in 1936 and in 1940. And in 1941, Mr. Acheson returned to government service as Assistant Secretary of State.

The six-foot, one-inch diplomat stayed in the state department under Secretaries Cordell Hull, Edward R. Stettinius Jr. and James F. Byrnes.

Await 60 Foreign Aviation Experts

### Group Flying Here For Demonstration

More than 60 foreign aviation experts are expected to attend a demonstration of new air navigation techniques at the Civil Aeronautics Administration Experimental Station here Monday and Tuesday.

The foreign representatives, all members of the International Civil Aviation Organization, will fly to Weir Cook Airport from such places as Australia, India, England, Europe and South America.

Devices to Be Shown  
Devices to be shown to the visitors will include those recently demonstrated at the Radio Technical Commission for Aeronautics show.

CAA officials said those attending will participate in flights employing the omni-directional range, the instrument landing system and the ground-controlled approach system.

The airmen were invited here to study the 15-year program contemplated by the United States for a streamlined, all-weather air traffic system.
