

Crash Kills 2 Brothers, Injures Five

Cars Collide On Icy Highway Near Walkerton

Two brothers were killed today and five other persons were injured in a two-car crash on an ice-covered highway near Walkerton, Ind.

Dead were Frank Brooks, 34, and his brother, Morris Brooks, 32, both of Kingsford Heights. Driver of the car, James W. Lipscomb, 20, of Kingsford Heights, suffered possible skull fracture. Two other passengers were slightly injured.

Frank Brooks drowned in a water-filled ditch in which he was thrown by the impact. Morris Brooks died of a fractured skull. The accident happened four miles west of Walkerton on U. S. 6.

Harvey C. Hoefling, 36, R. R. 2, Walkerton, driver of the other car, suffered lacerations of the face and leg. A passenger, Thomas Hayakawa, Chicago, suffered a skull fracture and possible internal injuries.

Four Injured Here

The Hoefling car collided with the car driven by Mr. Lipscomb, state police said. The injured were taken to Holy Family Hospital, LaPorte.

In Indianapolis, four persons were injured, one seriously, early today when their car ploughed into a concrete safety zone marker at the southeast of New York and Illinois Sts.

The driver of the car, Buren Tygett, 24, of 7312 Ralston Rd., was taken to General Hospital suffering from a deep cut in the back of the head and a possible skull fracture. Walter J. Denison, St. Francis, Kas., owner of the car, received a cut over the right eye.

Policemen Injured

Two women passengers, Ivel Wells, 34, R. R. 4, Box 440, and May Beatrice Cecely, 25, Rockville, suffered deep cuts about the head and bruises. They were in fair condition today in General Hospital.

Two policemen were injured slightly last night when their squad car struck a guard post in W. 16th St. just east of the White River bridge.

On a run to 3420 W. 16th St., the squad car hit the post after swerving to the right to avoid an automobile stopped in its path. Patrolman Stanley McDonald was treated in General Hospital for a cut over the right eye. Patrolman E. E. Gethner suffered a bruise on the head.

Youth Finds Out Why State Bans Fireworks

Twelve-year-old Larry Dunnam, 1420 Hoyt Ave., today understands why Hoosier lawmakers outlawed fireworks for Indiana.

Yesterday a friend of Larry's brought some fireworks back from a revival meeting in Kentucky and "divvied up" giving Larry a two-inch firecracker.

It was something new to Larry, whose experience didn't date back to the days when each July 4th brought lectures on how to handle fireworks.

Larry lit the fuse, tossed the cracker away. A minute later when it did not explode he decided the rain had extinguished it and picked it up to try again. At that moment the firecracker exploded, searing Larry's left hand.

He was treated at General Hospital for severe burns.

Philly Cabbies Join Walkout

PHILADELPHIA, Feb. 15 (UP)—Philadelphia's three million daily commuters were caught in a two-day travel squeeze today when taxicab drivers walked off their jobs in the fifth day of the city-wide transit tieup.

Most of the 3500 drivers for the Yellow Cab Co. turned in their vehicles shortly after last night, leaving thousands of Philadelphians stranded in the center-city area and dependent on train service.

A company spokesman termed the walkout "unauthorized." The drivers had previously threatened to strike at midnight, but their union leaders announced a postponement until Thursday.

The two strikes left residents in the metropolitan area with only a few cabs, private automobiles, trucks and trains for transportation.

Hoosier Wrecks Truck to Win Gamble for Life

SCHENLEY, Pa., Feb. 15 (UP)

Leon Arnold, 35, of Portland, Ind., gambled his life and won last night when he deliberately overturned his skidding trailer-truck, loaded with 19,000 bottles, on a slippery highway near here as it headed toward a 200-foot embankment.

Mr. Arnold, a driver for the Midwest Trucking Co. of Portland, escaped with only a skinned ankle. His 32-foot truck, which sheared off more than 30 concrete guard posts before overturning on the Schenley-Leeburg highway, was badly damaged.

THE ACCIDENT occurred during a rainstorm on a treacherous bend in the road flanked by a cliff and the embankment.

Mr. Arnold, who was delivering his cargo to the Schenley Whiskey Distilleries here, told company officials later that he lost control of the truck descending a steep hill.

Attacker of Woman Gets Reformatory Term

John Dillehay, 23, of 915 Wright St., was sentenced to 2 to 21 years in the Indiana Reformatory after he pleaded guilty in Criminal Court yesterday to a rape charge. A sodomy charge against the man was dropped.

Dillehay was charged with the brutal criminal assault of a 35-year-old woman Dec. 19 in the Garfield Park pavilion. Police said he met the victim in a tavern near Fountain Square and forced her to accompany him to the building.

He criminally assaulted her and slashed her twice across the face with a knife, police said. Dillehay was arrested soon after the attack through identification given by tavern employees.

would receive, unless they are disabled.

Today, as the bill was due out on the floor of the House for argument and possible amendment, Rep. Joseph Klein (D. Gary) took a poll of the Democrats and found not enough strength to risk calling down the measure.

"Fatherly Talk"

Due to the feelings of the Democrats pitted against the proposal it was feared the bill might be amended even to the inclusion of the Republican-backed sales tax.

Consequently, the entire Democratic side of the House was called before Gov. Schricker for "fatherly talk."

Democrats propose to finance their bill by a one-fourth of 1 per cent surtax on the gross income. They expect this form of taxation to bring in approximately \$25 million annually.

Republicans have refused to accept the surtax and in its place have proposed a 2 per cent sales tax. They tried to have their sales tax plan written into the bill while it was in committee but failed.

Republicans were expected again to attempt to amend the bill by striking out the surtax provision and writing in the sales tax plan.

Rep. Klein and other Democrat leaders in the House were fearful today that too many Democrats might join the Republicans in this proposal and thus defeat the administration's policy plan.

Rep. Klein had said early this morning he felt certain the administration bonus bill would pass the House. But then his poll of the House showed differently. He had said he felt encouraged about its chances of passage in the Senate.

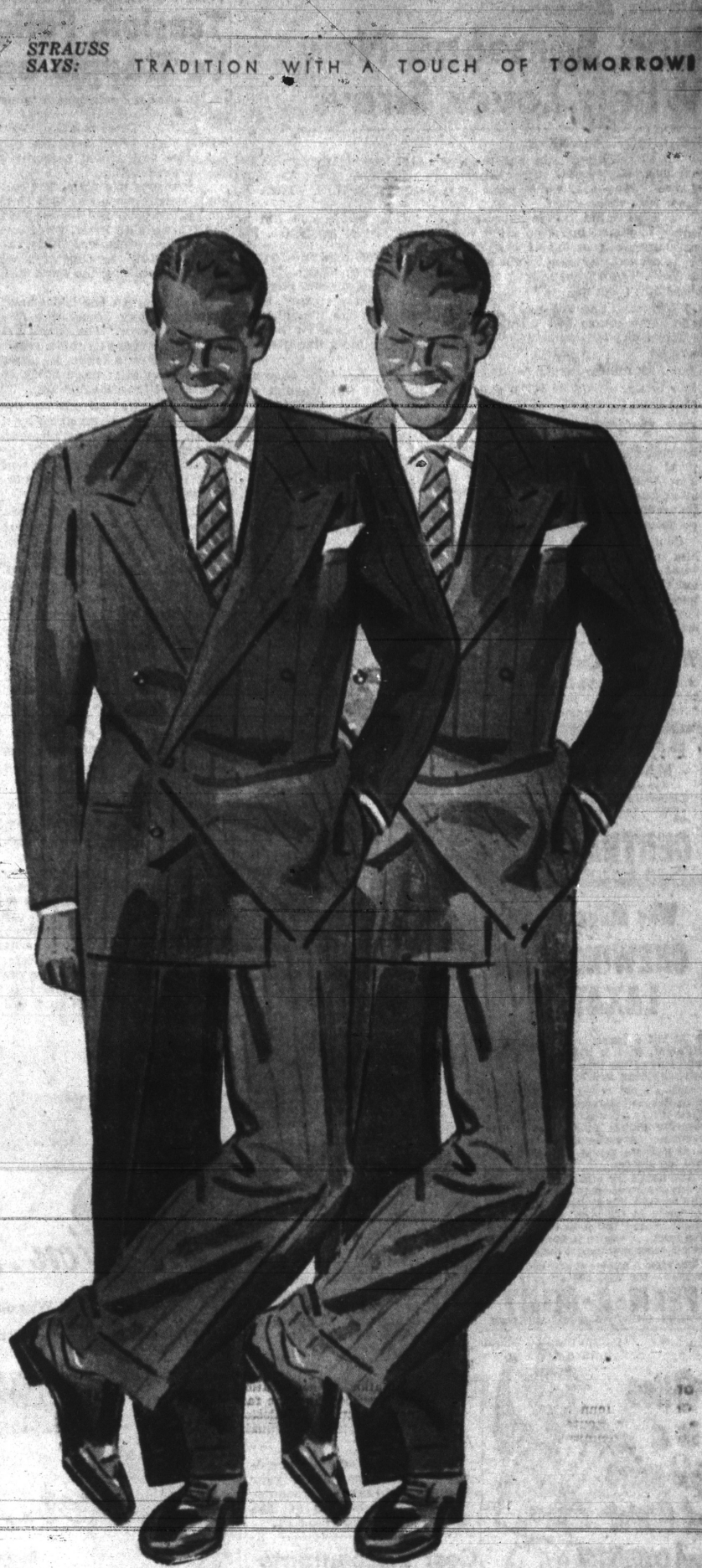
A Senate bonus bill, authored by Republicans, passed that assembly and is now being held in the House Military Affairs Committee. It provides no financing plan.

Today's revolt of Democrats was another indication that the administration's hold on the House majority was not iron-bound.

The blond dancer, picked up in New York on a fugitive warrant after she failed to appear here for trial, said she was just an innocent bystander when police raided a "reefer" party. She was arrested Sept. 1 with Mitchum, Miss Leeds and real estate agent Robert Ford. The trial is scheduled for Mar. 8.
