

## Sailor Dies After He Returns From 'Death'

OAKLAND, Cal., Jan. 18.—An Oklahoma sailor, who revived 10 minutes after being pronounced dead as the result of a street fight, died a few hours later, Navy doctors said today.

Paul Abbott, 40-year-old El Sobrante, Cal., car dealer, was booked on charges of murder, according to police.

Abbott and the victim, Dudley Pollack, 26, naval aviation mechanic of Bethany, Okla., started an argument in a tavern and efforts by doctors to keep him alive were futile. He died a few hours later.

The sailor suffered a fractured

skull and was rushed to Oakland Naval Hospital. While being administered oxygen, he apparently stopped breathing and doctors could detect no heart beat. He was pronounced dead of a basal skull fracture and the respirator was removed from his face.

Doctors said 10 minutes later Mr. Pollack was found to be breathing again and a check of his heart showed it was beating once more.

Despite Mr. Pollack's revival, an argument in a tavern and efforts by doctors to keep him alive were futile. He died a few hours later.

## Judge Not, Lest Ye Be Judged'

ENID, Okla., Jan. 18 (UPI)—Municipal Judge Doug McKeever reprimanded his old friend, Dr. Fred Entriene, for allowing his driver's license to expire.

"It's easy to remember your license renewal date," Judge McKeever scolded. "The license expires on your birth month every two years. Take mine for example," he illustrated. "It expires . . ."

## Hikes on GM Cars Approved by U. S.

WASHINGTON, Jan. 18 (UPI)—The government today approved wholesale ceiling price increases ranging from 4.4 to 6 per cent on five General Motors Corp. passenger cars.

Increases in retail would be about the same percentage-wise. The wholesale increases approved are 5.07 per cent on Chevrolets; 5.36 per cent on Pontiacs; 6.01 per cent on Oldsmobiles; 4.48 per cent on Buicks, and 4.41 per cent in Cadillacs.

New dollars and cents ceilings must be approved by the Office of Price Stabilization before being put into effect.



## Stolen Guns Recovered

## 4 Youths Picked Up In Holdup Ring Probe

Police today rounded up four youths for questioning about holdups and burglaries in which they believe robbery suspect Raymond Rutherford may have been involved.

One, detectives said, was a fellow member with Rutherford of a gang linked last summer to more than 40 robberies, burglaries and car looting here.

Two of the others, when arrested, had three of the eight pistols stolen Monday from Winters & Strieby, Inc., gunsmiths at 534 Massachusetts Ave.

Rutherford, 23, of 2037 Winter Ave., used a gun taken in the same burglary in his unsuccessful attempt to hold up Brightwood dry cleaner Charles Church Wednesday, detectives said.

Mr. and Mrs. Church and an employee subdued Rutherford so forcibly he was taken to General Hospital to have head wounds stitched up.

Rutherford was taken into Municipal Court 3 yesterday on a preliminary charge of robbery. Judge Phillip L. Bayt continued his case until Wednesday, and Rutherford was held when he failed to post \$10,000 bond.

The other four—all juveniles—were sent to the Boys School at Plainfield. Two are still there.

One, Clarence F. Golden, now 18, of 1747 Roosevelt Ave., was released Nov. 26 in a minister's custody. He is held for questioning.

So are a 16-year-old acquaintance of Golden's and two other youths, 15 and 16.
