

Bar Robeson From Going Into Canada

BLAINE, Wash., Feb. 1 (UP)—Negro singer Paul Robeson and his attorney, Vincent William Hallinan, were denied permission by United States immigration officers to cross the border into Canada yesterday.

John P. Boyd, district immigration director, would make no comment other than to say the action was taken "in the best interests of the United States."

Mr. Robeson, Paul Robeson, arrived here by automobile and was informed by written notice that he could not leave the United States.

Mr. Hallinan, who was Harry Bridges' attorney during the longshore leader's perjury trial, was taken off a Great Northern passenger train and also given written notice.

Both Mr. Robeson and Mr. Hallinan were en route to Vancouver, B. C., where they were scheduled to speak today at a convention of British Columbia members of the Mine, Mill and Smelter Workers' Union (Ind.).

Two border guards removed Mr. Hallinan from the train while guards at the U. S. immigration highway checking station stopped Mr. Robeson.

Mr. Boyd said that under immigration laws either a citizen or an alien can be prevented from leaving the United States. Both Mr. Robeson and Mr. Hallinan are citizens of the United States.

Churchill Gets Vote of Confidence

LONDON, Feb. 1 (UP)—Prime Minister Winston Churchill's government won a vote of confidence in the House of Commons last night on its new austerity program.

The vote was 309 to 278. The government victory came in the Commons vote on a motion of "no confidence" introduced by former Labor Prime Minister Clement Attlee.

The labor opposition motion had protested that measures in the new Conservative austerity program were "unfair" and "mean."

Mr. Attlee charged the government's act in introducing the austerity program conflicted with "optimistic" promises Mr. Churchill made last November, and left-wing Labor leader Aneurin Bevan charged in a stormy follow-up that Mr. Churchill "is not fit for his office."

The attacks on the Conservative Prime Minister came in the second day of Commons debate on the new belt-tightening program outlined by Chancellor of the Exchequer R. A. Butler to help Britain back on her feet financially.

Woman, 28, Cited In Lonely Hearts Racket Probe

SACRAMENTO, Cal., Feb. 1 (UP)—A 28-year-old beauty was indicted here last night on charges of swindling four love-sick men out of their hard-earned money.

Bobbie Blankenship, formerly of Turlock, Cal., now of Paducah, Ky., was indicted on four counts of using the mails to defraud four midwestern men out of \$750.

Assistant U. S. Atty. Robert Peckham said she would contact men through lonely hearts clubs and then write to say she wanted to visit them, establish a home and "become a loving companion."

WHEN THEY sent the money for her transportation, she failed to show up, the indictment charged.

Mr. Peckham said he believed many more men were involved that had not yet notified authorities.

Mr. Peckham said the girl was "very attractive" and used form letters in her correspondence. If the men answered the first letter, she led up to the point of asking them for money, Mr. Peckham said.

Vote Strike at 9 Briggs Plants

DETROIT, Feb. 1 (UP)—The CIO United Auto Workers voted last night to call a strike against nine Detroit plants of the Briggs Manufacturing Co.

A strike would idle about 18,000 employees of the auto body making firm. It also would throw out of work about 5,500 workers at Plymouth which gets bodies from Briggs.

Ken Morris, president of Local 212 of the UAW, said the membership voted 89.5 per cent to strike. The union constitution requires only a two-thirds vote, Mr. Morris said.

Mr. Morris said the strike vote must be approved by the international union before an actual walkout can be called.

The vote resulted from a dispute in the Briggs Mack Ave. plant last week over the elimination of six jobs in the trim department.

The union charged a speedup, and the dispute touched off a wildcat walkout which idled about 14,000 workers in six Briggs plants and the Plymouth workers.

Carpet Serves as Map

HENDERSONVILLE, N. C. (UP)—A rug company here completed an unusual carpet for the student union building at the University of Washington. The rug was designed and hooked as a map of the world as viewed from a projection from the North Pole. Fitting from wall to wall, it measured 18 by 23 feet.

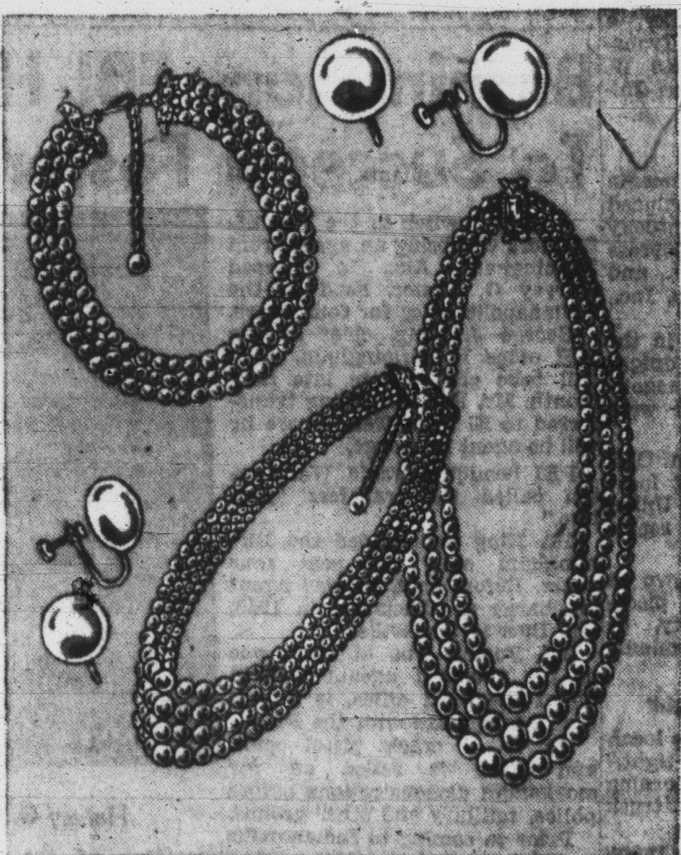

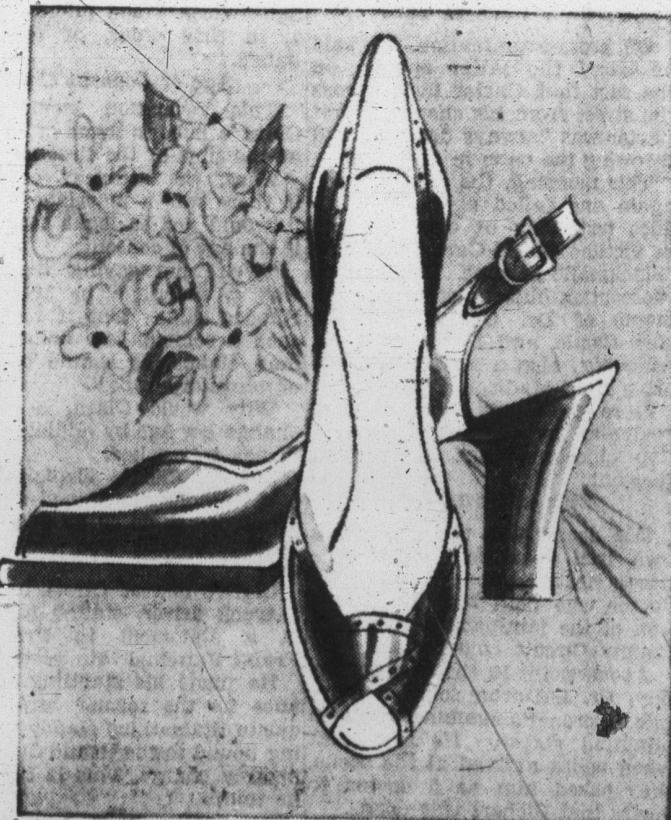
