School spokesmen said the seniors walked out Friday because Principal David Jones refused to permit them to attend a "career day" program at nearby Selma High School. Some of them said they went to Selma anyhow. Mr. Jones could not be reached for comment.

Some of the pupils said Mr. Jones had banned the wearing of blue jeans by girls students all year. They also said he hinted they might not get to take an annual senior class trip to Washington next month.

Two Given 10 Years in Escape Case

Two of four prisoners, who overpowered sheriff's deputies and escaped in the sheriff's station wagon last summer, were sentenced to 10-year terms today. Gilbert Hall, 28, and Walter Secrest, 23, were allowed to plead guilty to lesser charges of vehicle taking and auto banditry after a conference between Sheriff Smith and the prosecutor's office.

They had been charged with kidnapping, which carries a mandatory life imprisonment. The two deputies, Hardister Buckner and George Rushton Jr., testified that Hall, Secrest and two other prisoners made a break for freedom as they were being returned to jail from the Public Health Center, July 24.

Deputy Buckner testified the four prisoners were chained together in the back of the station wagon as they started the return trip to the jail.

Snatched Gun
He said Joe E. Brown, 37, now serving a life sentence for another kidnapping, "snatched my gun out of the holster."

Deputy Buckner said he was forced, at gunpoint, to drive into an alley several blocks away. There the prisoners took the other deputy's gun and forced them to give up the keys to unlock the chains.

At the time of the escape, Hall and Brown were awaiting trial on the earlier kidnapping charge. Secrest, on parole from the Indiana Reformatory, was awaiting trial on a grand larceny charge.

The fourth escaping prisoner, Willie Carter, 25, was awaiting transfer to the reformatory on a 10-year robbery sentence.

Asked for Change
Today Hall asked Judge Harry O. Chamberlin of Criminal Court 1 to be sent to State Prison because he said he had served a burglary sentence at the reformatory and "the officers up there don't like me." The judge complied.

Secrest was sent to the reformatory where Carter is now serving his original sentence. Brown is in state prison.

County Democrats Stay Neutral 'for Present'

The Marion County Democratic organization will stay neutral at suddenly have found themselves present in the party's scramble for among candidates for the presidential nomination.

Although many Indiana Democratic leaders, including Gov. Schricker, have indicated their preference for Gov. Adlai Stevenson of Illinois, Indianapolis party leaders are "recognizing a growing sentiment" in favor of U. S. Sen. Estes Kefauver of Tennessee.

President Truman's announcement Saturday he would not be a candidate for re-election caught the local organization without an alternate candidate. County Chairman David Lewis declined to put the organization on record for any one candidate, commenting that Gov. Stevenson is a "very able man" but "sentiment for Sen. Kefauver is growing here."

Kefauver Rally Set
The Kefauver-for-President committee here, headed by Earl Oaks, 2349 Centennial St., moved into high gear after President Truman's announcement and called a major political rally for the Tennessee Senator for 8 p. m. today at 1922 N. Moreland St. Speakers will include Charles H. Mains, unopposed candidate for the Democratic prosecutor nomination; Andrew Jacobs, former Congressman and Dr. John Wyttenbach, unopposed Democratic candidate for coroner.

Study Plan to Move GI Mental Patients
The Indiana Department of Veterans Affairs is conducting a survey to determine the number of former Hoosier servicemen now confined to state mental hospitals.

State officials estimate there are 200 such cases in Indiana. When the survey is completed, the state will attempt to have the veterans moved to Veterans Administration Hospitals here.
