THE following constitution for a MORAL society, was adopted at a meeting of the members sometime last winter, but the publication thereof has from various causes been postponed until the present time.—

It is requested that all persons who have hitherto become members, and also all who wish to join the society, would meet in Madison, at Major Henry Ristine's on the second Monday in August next, for the purpose of making further regulations relative to the said institution.

BEING fully persuaded of the truth of that text of sacred writ which declares "That righteousness exalteth a nation," and that "Sin is a reproach to any people," and knowing that it is the duty of every friend of man, as well as Christian, to endeavor to suppress vice, and promote the interests of morality, and good order; and being sensible that concert, and united influence, will be necessary for carrying into effect, such desirable objects; We therefore agree to unite ourselves together, into a Moral association, for the purpose of promoting morality, and using our individual exertions, to suppress vicious examples, by bringing the guilty under the notice of those laws of our state, which respect vice and immorality.

Rule 1st. Each member of this association, shall use his influence to promote the general objects of this institution, viz. the suppression of vice of every kind, and promotion of virtue and morality in general.

Rule 2nd. Each member shall use his influence, both by precept and example, to inculcate the necessity of good morals to the order and peace of society, & the stability of civil institution.

Rule 3rd. The association shall appoint yearly, a standing committee of seven at least of their members, whose business it shall be at each stated meeting, to make report of the prosecutions for immoral conduct, and give an account of the state of morals within their knowledge.

Rule 4th. The members of this association shall meet yearly on the first Monday in March, for the purpose of electing the respective officers of the society, and to concert such measures, and adopt such resolutions as will be judged expedient for the further promoting the objects of the institution.

Rule 5th. There shall be appointed, as the standing officers of the society for each year, a Chairman, Secretary, and Treasurer, who shall continue in office until their successors are elected.—It shall be the duty of the chairman, to keep and preserve good order in the society, and to do all other duties of his office which may be pointed out by the laws of the association. The secretary shall record the proceedings of the society, and shall have the care of the records, and keep a fair and just account of all monies paid to the treasurer by the society.—It shall be the duty of the treasurer to pay out the

money according to the provisions of the society.

Rule 6th. The society shall in addition to the general meeting provided for in the rule of this constitution, have a quarter annual meeting, & over, the standing committee shall have it in their power they conceive it necessary, to an extraordinary meeting of members of this association, giving public notice thereof in the public prints, two weeks previous to such meeting.

Rule 7th. No person shall or continue a member of this association, who is not at least in his own conduct—But all characters shall be willingly received as members.

Rule 8th. All gambling, ches of the peace, Sabbath breaking, profane swearing, disorderly taverns; and every species of immorality, cognizable by the laws of this state, shall be subject of animadversion and proof; and if any person guilty of such immoralities, shall be refractory, after due admonition being given, (if such admonition be thought necessary,) any member of this association under notice it shall happen, shall take due steps to have such person brought under the notice of civil authority, and punished accordingly.

Rule 9th. Any member of this association who shall neglect his duty, shall be dealt with by the society.

Rule 10th. This association shall have full power to make such by-laws as may be necessary for regulating the proceedings therein, provided, such by-laws are not in opposition to this constitution.

Rule 11th. Each and every member of this society shall be bound to pay the treasurer thereof, at least once a year, such sum of money as shall be deemed necessary, by a vote of the majority of the members present at meeting, for defraying the expenses of the institution.

Rule 12th. This constitution shall be published in the "Indiana Republican" for three weeks successively, after which time members of the society will be bound to attend to the objects of the institution.

Rule 13th. No article of this constitution shall be altered, changed, or amended, without the concurring voice of a majority of all the members: nor is any person to be removed from membership in this association, without the concurrence of two-thirds of the members present.—No member shall be withdrawn himself from the society (having incurred no surety,) unless he has undergone trial for his misconduct.
