At the first appearance the worms were then destroyed much of the grass and weeds. After hoeing he planted White Beans between the hills, without soaking in brine. These the worms did not eat off entirely; but the Corn continued to flourish.

THE NATIONAL DEBT.

Ques. Supposing this debt to be only 910 millions of pounds sterling at present, (though it is much more) and that it was all to be counted in shillings, that a man could count at the rate of 100 shillings per minute, for 12 hours each day, till he had counted the whole, how much time would he take in doing it?

A. 31 millions 850 thousand pounds sterling, and at 5 per cent. per annum, 45 millions 500 thousand pounds sterling.

Q. How doth the government raise this interest yearly?

A. By taking from those who lent the principal and others.

Q. When will the government be able to pay the principal?

A. When there is more money in England's treasury alone, than there is at present in all Europe.
