But it seems to an on-looker that the performers at the theater might have been properly arrested also, for pursuing their usual avocations on Sunday.

The State Tax Commissioners have reduced the assessment of the Air Line \$1000 a mile on the main line in Indiana, to \$14,000 a mile on its 116 83 miles in this State; side track 32 13 miles is placed at \$3,000 a mile; rolling stock \$2,000 a mile, a decrease of \$5000, improvements \$67,000. Evansville branch—54 21 miles, \$10,000 a mile. Sidetrack, 8.76 miles, \$2,500 a mile, rolling stock \$2,000 a mile. The Rockport and Cannelton branches are assessed at \$5,000 a mile.

The Black Diamond road is not yet placed on the assessment list, though it will be, when completed, a great deal more valuable than some others.

The Board has assessed the Cumberland Telephone Co., on 215 miles of line, at \$200 a mile, double what it was assessed at last year, and counting the extensions made last year, 68 miles, nearly treble.
