SENATOR A. J. BOWSER SAYS IT  
IS IMPOSSIBLE TO GET A  
COURT FOR GARY AT THE  
PRESENT TIME BECAUSE IT  
IS IMPRACTICAL.

## KLIVER SAYS BUSINESS SHOULD BE DONE AT HUB

JUDGE HUBER LOOKS FOR ALL SORTS OF  
TROUBLE IF GARY SECURED COURT, AS  
ALL CITIES WOULD WANT ONE, BUT  
DECLARES THAT GARY IS IN NEED OF  
A SUPERIOR COURT.

SENATOR A. J. BOWSER: "I think that the attempt to get a court for Gary at the present time is not only impractical but it is impossible. To draft a measure for the locating of a superior court in Gary and have it passed through the legislature will take at least two years, even if the legislature is in favor of it. The point I would be in favor of would be to join the large cities of northern Lake county and make it one first class municipality with a new name. In two years, which is about the length of time that this could be done in, there would be one hundred thousand people within its limits."

REPRESENTATIVE-ELECT WM. H. KLIVER: "I am heartily in favor of a court at Gary and I believe that the people of Gary are entitled to it. I think, however, that their methods of going about it are questionable and that their attitude towards the other cities in the county is wrong. I do not think that the legislature will give two separate courts to the people of Lake county. My opinion of the matter is that all of the courts should be located at Crown Point, the county seat, which is the logical place to transact court business."

ATTORNEY CLYDE HUNTER: "A superior court for Gary would be a wonderful help to this city, but to be
