SHIVELY LOOMS UP IN RACE

South Bend Man Is Said to
Have the Breweries With
Him in Fight for United
States Senator; Looks
Strong Now.

HE HAS EVER BEEN A GOOD LOBBYIST

Therefore They Would Reward Him
With the Toga—Ellis Seales Says
Real Battle Will Lay Between
Kern and Slack After All, and
Awards Plum to John W.

It look like a good guess. This Shively-brewery story came out at this meeting for the first time, and before the conference was over there were many who believed it.

The meat of the story is that the brewers of the state are for Shively in return for the work he did against the high license bill when it was before the legislature two years ago and also for his unsuccessful effort to prevent the passage of the county local option bill at the special session in September. Those who watched the progress of events at these two sessions know that Shively was one of the most effective lobbyists in the entire outfit against the thousand-dollar license bill, and that it was through his efforts as much as those of anyone else that it was defeated. Shively worked like a trojan. Of course, it was accepted by everybody that he was merely a hired lobbyist in the matter just as many other able lawyers were em-

ployed to defeat Kern, but Slack is not and never has been satisfactory to the brewers and Taggart does not like him because he has fought the Taggart machine. Therefore, it is pointed out by some, what would be more natural than that Fleming should throw the Twelfth district to Shively, thus remaining in line with the brewers and at the same time defeating Kern.

If this were to work out according to this talk Shively could be elected. I still stick to the statement that the real fight is between Kern and Slack, and that none of the other candidates has even a look in. They may have their eyes set on the senatorship two years hence, provided the legislature is democratic, but there is not one of them outside of these two that really believes he has a show to be elected.

Ellis Seales says that the democratic legislators have "come and went" what do they know that they did not know before they came?

The way it looks now is that they do not know a single thing that they did not know before, unless it is that the brewers of Indiana are for B. F. Shively of South Bend for United States senator. And this is merely a guess, but there are some things that make Shively legitimate as a paid lobbyist for various interests, and everyone concedes that Shively did a mighty good job of it.

Story Is Retold.

In this connection there is retold now the story of the little champagne supper at the Denison hotel the night after the high license bill was defeated. Crawford Fairbanks, owner of the Terre Haute Brewing company, and chief manipulator with Albert Lieber of this side of the brewery politics of the state, was so happy that he threw a supper. Corks popped and they had a good time and everybody was complimented for the good work done in that fight.

Then during the last campaign a brewery attorney went over the state planting money in the various counties for use in the democratic campaign. In planting this money he let it be known that it was "Shively money," and that if the legislature was democratic Shively would be elected United States senator.

Double Cross for Lamb.

After this story was recalled, yesterday and last night, there cropped out another one to the effect that Crawford Fairbanks is double-crossing John E. Lamb of Terre Haute, who is also a candidate for senator. Fairbanks is ostensibly for Lamb, and has let it be known that he is working for him. But a man who stands close to Fairbanks "leaked" yesterday and told a friend that Fairbanks is only out for Lamb for the purpose of keeping the legislators of the Fifth district from going to Slack or Kern. He said that when the right time comes Fairbanks will have Lamb withdraw from the race and that the vote of the Fifth district will then go to Shively.

Then there is another situation that lends some color to the story that Shively has the brewery support and that this makes him a formidable candidate. That is the fact that Steve Fleming controls absolutely the vote of the Twelfth district and that if he finds that Edward G. Hoffman of Fort Wayne cannot be elected senator he will throw his vote to Shively. Fleming is brewer. He would do anything to defeat John W. Kern, because there is a cordial, mutual personal hatred between the two. Fleming could probably throw his Twelfth district vote to Shively, thus remaining in line with the brewers and at the same time defeating Kern.

If this were to work out according to this talk Shively could be elected. I still stick to the statement that the real fight is between Kern and Slack, and that none of the other candidates has even a look in. They may have their eyes set on the senatorship two years hence, provided the legislature is democratic, but there is not one of them outside of these two that really believes he has a show to be elected.

Thinks Kern Will Get It.

There is even a possibility that Kern may be elected on the first ballot in the democratic caucus, but this is not likely. It is said that there are some members of the legislature out in the state who are standing for the candidate from their district who have signed statements agreeing to vote for Kern if their votes are needed to elect him, even going so far as to say they will do this on the first ballot, if necessary.

So it does not look like it will make much difference whether the brewers line up for Shively or not.

Not only is the contest for senator radically settled, but the speakership is clinched also. Representative Tom Honan of Seymour will be elected speaker beyond a doubt. Senator Frank Kistler of Logansport is slated for the minority leadership in the senate, and Representative Fred King of Wabash will be elected republican floor leader in the house. This appears to be the slate and it will probably go through.

The democratic conference was a pretty good sized affair, and the democrats present were happy as June bugs. They got each other around the neck and almost cried for joy over the fact that at last the arty is to have charge of the jobs in the state. There were more smiles to the square inch among them than have been seen before among Indiana democrats since 1894. But they didn't accomplish anything. They just talked and then had a banquet at the expense of the Marion county representatives and then went home.
