I. U. DESPERATE OVER COMING PURDUE GAME

Crimson Hunches Almost Against Hope for Basket Ball Victory.

BLOOMINGTON, Ind., Feb. 24.—The Crimson break Purdue.

With the close of the 1920 basketball season already in sight and with the Boilermakers-Indiana game at Lafayette only two days away, Crimson fans were asking this question. Reports from Purdue indicate that the Boilermakers supporters are slightly uneasy over the Indiana game, fearing that the Purdue combination, which has been showing the way in the conference fight, may slumber in the critical Hoosier basketball game.

Indiana fans believe the Crimson will win. Indiana, they say, is desperate, realizing that much of the success of the 1920 season depends upon the outcome of the game Wednesday evening.

Four games remain on the Indiana schedule—all of them conference games. Ohio State will come here next Saturday night. Indiana will meet Northwestern at Evanston on March 6, and Michigan will wind up the season here March 15. The Crimson already has defeated Ohio State at Columbus, Northwestern here, and Michigan at Ann Arbor. Little doubt is felt here as to the results of these games.
