DON'T PAMPER YOUR BOY.

The boy has been a problem to his elders ever since the first sun-tanned—and hickory tanned—son of man ran barefoot through the primeval wilderness. And in nearly every period of history fathers have used much the same means of rearing their young. Men have always experienced sympathy akin to pity for the boy born "with a silver spoon in his mouth." It has been part and parcel of existence that lads who have had to rough it and fight their way have made the stronger, more self-reliant and companionable men. The Spartans took lads of seven from their mothers, made them wear the same scanty clothing summer and winter, sleep on the bare ground and train ceaselessly in the hard art of war. And the worst of it is that in most cases the money has been handed out by indulgent parents to youngsters who know all too well that there is more where it came from.

Many fathers who look back in pleasant remembrance to their boyhood, when five cents was worth working an hour to earn and a quarter was a veritable fortune, will regret the present fashion. They will remember the days when there were no movies, no bicycles, no gymnasium, no clubs, nor any of the other myriad interests that have become a part of everyday

The boy who is taught the worth of money by being encouraged to work for it and permitted to spend it or save it at his discretion will never be a spendthrift or an aristocrat. But the boy who is being pampered—poor chap—has a hard row ahead when he goes from under the parental roof. Making it easy for the lad is making it hard for him.

## WOULD CHECK SOCIALISM.

Speaking at the Rhode Island Republican State convention, Congressman Simeon D.
