PROVED AS BY THIS PETITION PROVIDED BY TAXATION.

That said highway further represents your petitioners, and indicates level from one end to another; that from Summer Street to Clay Street is about sixty-six (66) feet in width; from Clay Street to Forsyth Avenue and on Forsyth Avenue to 151st Street it is about sixty (60) feet in width; and on 151st Street from Forsyth Avenue to Kennedy Avenue it is about ninety (90) feet in width. That said highway in all its course from Summer Street to Kennedy Avenue, as above outlined, is at present in good, decent and adequately improved with concrete and macadam which has practically worn out and leaves said highway in bad condition.

That said highway is a main travel highway and forms a part of a travelled thoroughfare from Indian Harbor Beach, East Chicago to Hammond, and points southward and westward, and to Gary and points southward, and if properly improved would be of great use. That said entire highway sought to be improved by this proceedings is less than three miles in length and lies partly in North Township, Lake County, Indiana, and partly within the corporate limits of an incorporated municipality and partly within the corporate limits of the Cities of Hammond and East Chicago in said township, county and state.

That said highway herein sought to be improved, connects Summer Street, an improved highway where the same connects with the corporate limits of the City of Hammond, and with the City of Hammond, and with Kennedy Avenue in the City of East Chicago. That said Summer Street, the place of beginning, is improved with asphalt macadam and that said Kennedy Avenue, the terminus of said proposed improvement, is improved with asphalt macadam.

Your petitioners further, request that their recommendation as to the width and character of the improvement herein prayed for is as follows: One (1) course concrete eight (8) inches thick and thirty (30) feet wide throughout the entire length of said proposed improvement.

Your petitioners further say that it will be of great public utility to improve said highway as in this petition prayed for.

Wherefore, your petitioners respectfully pray that your Honorable Body may take the same improvement to be made in all things according to law by taxation, all without submitting the question of building same to an election of the voters of North Township, said county and state, and your petitioners will ever pray.
