COUNTY CLERK, CLIFFORD H. LONG REFUSES TO HELP RECOUNT THE BALLOTS

In the petition for a recount of the ballots cast at the Special Election July 22nd, 1919, a hearing was had and determined by Court that a commission of three men be appointed by the Court to make such recount.

The judge of the court appointed George M. Crist, E. P. Trapp and Shepherd Whitecomb as members of this commission, County Clerk, Clifford H. Long by virtue of his office is the Clerk of this commission.

This commission assembled 9th at 9 a. m. in the office of the Clerk and at that time the Clerk, Clifford H. Long refused to assist and the result is this commission is still in session.

Mr. Long informed this commission that he had been legally advised to refuse to assist in counting the ballots at this time, this refusal will lead into other legal actions that will determine whether this Clerk acted according to law or not.

The action of the Clerk and the determination of the North Vernon Removalist ring not to allow the ballots recounted in almost convincing evidence of an unfair election; that corruption exists in the ballots, if the removalist were sure this did not exist any tax payer knows they would be the first to ask that the ballots be gone over by good reliable men to establish the fact they had honorably won the election.

Will they say that George M. Crist, E. P. Trapp and Shepherd Whitecomb would not give them a fair deal? This is all they can say. It is a shame when Jennings County has to be given such a reputation as will be spread broad cast over the State of Indiana.

The North Vernon Removalists can furnish no excuse for not wanting a recount other than they did not get to pick the men and one knows that if this right was given them they would not be able to select better men than Judge Carney selected.

Mr. Long was not asked by the Commission to surrender the ballots to them, he as the clerk of the Commission would be in possession of the ballots, besides this Clerk was given men to guard this commission and the ballots while the recount was made just why he objected to this remains to be solved.

The tax payers of the 11 townships have united in a demand that the results of this Special election be examined in a fair and honorable way, this right should not be denied.

These Few Removalists Ringsters will wake up to the fact that it is not Vernon that is after them this time; they will find that at least 75 per cent of the tax payers of Jennings County are behind the job.

OBITUARY

Wilbur H. Heacock, was born Dec. 26, 1850 in Morrow Co., Ohio, and died at his home near Grayford August 4, 1919 aged 68 years 7 months. He came with his parents to Virginia when two years old and to Indiana when at the age of eighteen years.

He was married to Lillie M. Gray Nov. 7, 1878, in the town of Vernon. The first six years of their married life was spent near Columbus, the rest of their life in Jennings County.

Before his marriage he attended the Hopewell M. E. church and became interested in living a religious life, but never joined the church. He was the last of his immediate family and leaves a wife to mourn the loss of a kind and affectionate husband.

Funeral services were conducted by Rev. Lewis King and burial took place at the Edwards Cemetery.

STATE ROAD MAY BE A STATE HIGHWAY

Monday, a delegation composed of citizens from Dupont, Vernon, North Vernon, Scipio, Elizabethtown and Columbus were before the State Highway Commission as well as before Governor Goodrich showing good reasons why the State Highway should not branch off at Columbus following the old State road from Columbus, through Elizabethtown, Scipio, Queensville, North Vernon, Vernon, near Grayford, Champaign, Dupont, Wirt, North Madison and Madison.

This delegation met in the office of William Guthrie of Dupont and Indianapolis. Mr. Guthrie's office is in the Terminal Traction Building. Mr. Guthrie acted as Chairman. At his office it was decided that Messrs. Geo. M. Crist of Grayford, William Springer of Elizabethtown and Orville Platter of North Vernon would present the cause to the State Highway Commission and to Governor Goodrich. Mr. Platter read statistics showing the large population that this road would serve. Good forceful speeches were made by both Mr. Crist and Mr. Springer showing the important reasons why the State road from Columbus, should be made part of the State Highway system. It was pointed out that this road was one of the principally travelled roads of Indiana, also that Madison on the Ohio river to Indianapolis and to Chicago, Ill., and route over the old state road through Vernon and the other points mentioned is the nearest and best route. Also it is important that Madison be easily reached from every direction since one of Indiana's State Institutions, the Southeastern Insane Asylum is located there. Those interested are not wishing or trying to take any other route away from Ripley or Scott counties, but are after an independent and a new additional road. The roads heretofore outlined by the Commission for the State as well as this part of the state reaches almost every section, and with this state road from Columbus to Madison made part of this state highway system, southeastern Indiana will prosper as never before, and by her prosperity, many times repay the state for the maintaining and building of these state highway roads.

The question of where Jennings county seat is located has nothing to do with the establishing of the state road in Jennings county as a state highway, as Mr. George Crist told to the State Highway Commission, the road extends through both Vernon and North Vernon.

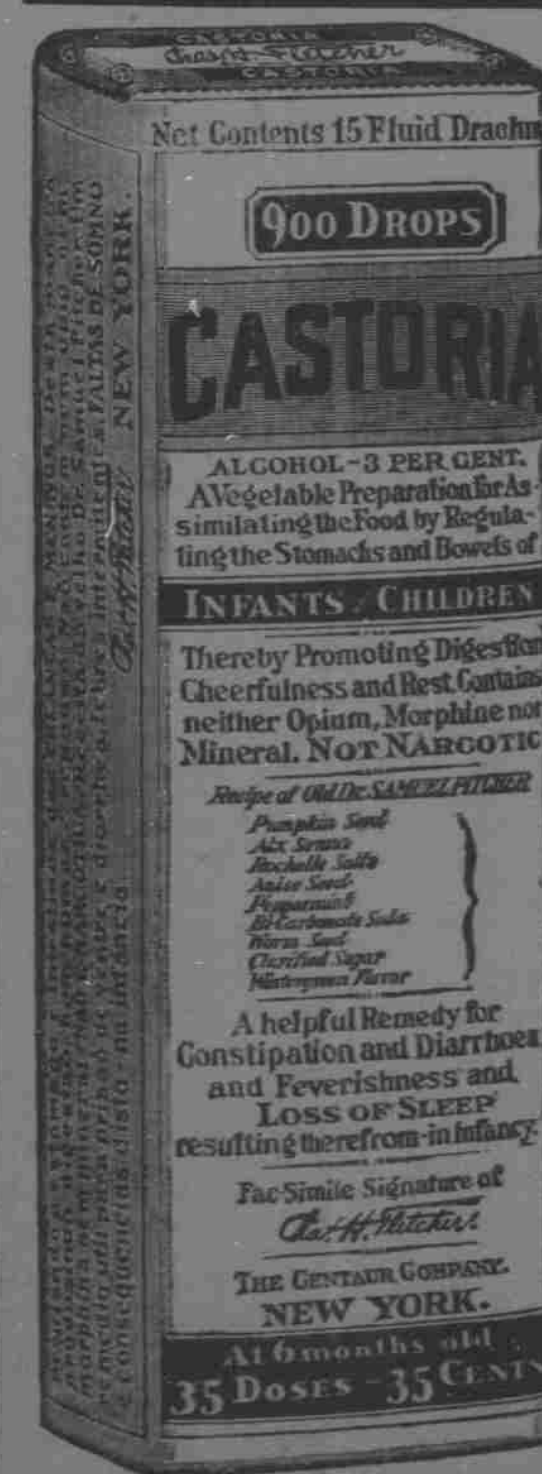
