Execution of Henry Magruder.

From the New Albany Ledger. Yesterday, Friday, October 26th, Henry C. Magruder, the guerrilla, was executed in the yard of the military prison at Louisville, in accordance with the sentence of a military commission, of which Col. H. B. Carrington was president. Magruder was arraigned on the charge of murder, of which seventeen separate specifications were alleged. Of these he was convicted on eight, and acquitted on nine. The Louisville Democrat gives the following account of the execution:

The fact being announced that the execution would take place at the military prison yesterday, drew a large crowd to the vicinity. The roofs of all the houses were crowded with eager spectators to see one human being launched into eternity, a fact which we record with regret, as it shows the morbid feelings of our people. The scaffold was erected in the center of the military prison yard, six companies of the 125th colored infantry being drawn up in a hollow square around the same. About half past three the condemned man was brought out of his room, coming to the scaffold between Father Brady, his spiritual adviser, and Colonel W. C. Whitaker, his counsel during the trial. He had a cigar in his mouth, which he threw down as he commenced to ascend the steps of the scaffold. After the scaffold had been mounted, Captain Neal, of the Eighteenth United States regulars, read to the condemned man the charges and specifications, together with the sentence of the court, and the approval of the same by the commanding General.

During the reading of the same the prisoner looked around with unconcern upon the large crowd that had collected to witness the sentence of the commission carried into effect. After the reading of the charges, &c., Magruder knelt with Father Brady, of the Catholic Church, and offered up a prayer to the Almighty. After this his arms and legs were tied, and he was placed upon the fatal trap. He was asked if he had anything to say, to which he replied in the negative. The rope was then placed around his neck and the white cap drawn over his face. At the given signal the trap was sprung and H. C. Magruder was left suspended between heaven and earth. He struggled for some
