The British Parliament has again been prorogued until the 19th of December.

Rev. Thomas A. Sharkey has been elected to succeed Bishop Odenheimer as Bishop of Northern New Jersey.

Jacobi Abbott, the author, died at his home at Farmington, Me., on the 31st ult. He was seventy-seven years old.

Buckstone, the famous comedian, died at Sydenham, Eng., on the 31st ult. He was seventy-seven years old.

Mrs. N. Elliott, of Sedov, Kan., was killed and horribly mutilated a few days ago by the explosion of a coal oil lamp.

A Chinese will, entirely in Chinese characters, was recently offered for probate in the Surrogate's office, in New York City.

In a late billiard match in New York City, Schaefer defeated Shasha by a score of 3,000 (the number of points to be made) to 2,600.

Ex-Congressman L. N. Morris, of Quincy, Ill., died at his residence in that city on the morning of the 29th, aged forty years.

W. H. Henderson, commercial editor of the San Francisco *Chronicle*, recently committed suicide by shooting himself twice in the head.

A. B. Wakefield, a prominent St. Louis lawyer, was convicted of perjury on the 29th, and sentenced to two years' imprisonment in the penitentiary.

Major General Hooker died at Gandy City, Long Island, on the afternoon of the 29th. His death was sudden. General Hooker was sixty years old.

Lady Epoch, wife of Sir Francis Croft of England, well known for her attempt to pass off a spurious child on her husband, died on the 31st ult.

Up to the 27th of October, 44,453,850 standard silver dollars had been coined, of which 12,281,910 were in circulation, the remainder being in the Treasury.

The wife of George Francis Train was found dead in her bed a few mornings ago at her father's house, in New York City. Her death was attributed to paralysis of the heart.

An agricultural and mechanical fair (the first ever held in that city) was opened in Washington on the 28th. President Hayes and several members of the Cabinet were present.

Official statistics of the recent inundations in Murcia, Spain, show that four-tenths of the arable land in the Province is ruined, and that 8,000 persons were drowned or are missing.

The hundred and fourth Mormon immigration ship, *Mountain Home*, arrived at New York on the 29th, for the 29th. They were from Scotland, Wales, England and the Scandinavian countries.

On the 25th, at San Francisco, the noted St. John's Hospital was opened, its best time, and made a mile in the unpreceded time of 2:12½—Barrel's greatest achievement being a mile in 2:13½.

An Alexandria (Egypt) telegram of the 28th says the second Coptic's needle, which was lost on the point of being sent to the United States, had been seized by creditors of the Egyptian Government.

During the week ending October 30 the billion in the Bank of England decreased \$5,800,000. During the same period the Bank of France lost \$4,200,000 in specie. The bulk of the decrease was sent to the United States.

The New York *Express* of the 30th ult. reports great activity in the real-estate market of that city, and, on authority of one of the leading operators, says there had been a rise of seventy-five per cent. in prices since last March.

A few days ago a little seven-year-old boy, a son of Mr. and Mrs. Andrew Resnick of Astoria, New York, got hold of an oil lamp, his mother and father had recently returned from Europe. The boy had been left alone in the room, when he was taken to the hospital, and a physician and nurse to attend him. The boy was a yellow fever patient at that place, seventy miles out of Memphis.

The remains of W. S. Bodie, the original discoverer of the Bodie (California) mining district, and who perished in a snow storm nearly twenty years ago, were discovered on the 29th, about a mile southwest of the town of Bodie.

General Sherman has received a dispatch from General Grant stating that the latter will be unable to attend the reunion of the Army of the Cumberland in Washington, on the 20th of November, as he has an engagement for that date at Indianapolis.

The Supreme Court of Massachusetts has rendered a decision in the case of Mr. H. J. Munson, the Adventist minister who married himself in presence of his congregation at Worcester some months ago, to the effect that there was no legal marriage.

A Washington special of the 30th ult. says the National Bank of America, which was increasing their circulation rapidly, and the Bank of America, which Printing was being crowded to furnish the news, the increase in October would be over \$3,500,000.

Billy Young, who was recently tried at Colorado, Mo., for the murder of the Spencer family, and was taken from his house on the 28th and hung to the cross-tree of the gate in front of his residence. About twenty of his neighbors were present at the execution.
